NO to Austerity Treaty

THE forthcoming referendum on the Austerity Treaty in the 26 Counties is an opportunity to send out a clear statement of intent that people are not prepared to cede any more power to the undemocratic and unelected bureaucratic elite that is the EU.

Since the first referendum on joining the then EEC Republican Sinn Féin have consistently warned of the steady seepage of economic and political power to Brussels.

The contempt which the political establishments in both Leinster House and the EU hold for the will of the people was exemplified when the people of the 26 Counties rejected both the Nice and Lisbon treaties and yet were forced to vote on them again.

Rather than accepting and acting on the will of the people in the first Lisbon referendum, the then head of the 26-County Administration Brian Cowen slavishly apologised to his political masters in Brussels and immediately promised to force people back into the polling booth until they did what was required of them.

In fact when the people of Holland and France rejected the proposed EU Constitution they too were ignored and it

Shell to Sea spokesperson sentenced to prison

ON February 21, Shell to Sea spokesperson Terence Conway was handed two three-month prison sentences for protesting against Shell's Corrib Gas Project. He is currently on bail pending an appeal in the circuit court.

Throughout the week local residents were protesting on the roads while many of their supporters were in court in Belmullet, which so far has resulted in twelve people being convicted of 33 charges resulting in fines totalling €5.825.

Two more people have to face the courts with 21 charges between them. One person was given a two-month sentence suspended for 12 months in exchange for signing a bond to keep the peace. In all 19 protestors faced 80 charges between them for disobedience".

The last case to be heard on February 20 resulted in a conviction and fine, despite what looked like very clear video footage refuting the charge. There were numerous contradictions Garda

During is case, Terence Conway spoke and gave evidence about the injustices faced by the community in

"What we have been subjected to by the actions of Shell and the State is worthy of a dictatorship. The police are working as an arm of the oil companies.

When the Judge responded that "This is a law-abiding country and there is justice for all in the country," about 25 local residents and supporters walked out of the courtroom in protest.

On February 22 a stenographer was disallowed from making an audio recording of the court proceedings, despite this being common practice. When asked for a reason by the defence council, the Judge ruled that he did not want it falling

into 'the wrong hands.'.

On February 20 local residents blocked Shell's haulage route between Bellanaboy refinery and the compound in Glengad while many of their supporters were up in court.

All-Ireland anti-fracking

A NEW organisation set up to campaign against fracking is backed by advisers in the areas of economics, law, science, public health and policy development according to a report on February 17

Good Energies Alliance Ireland (GEAI) will cover the entire country and will also promote ways in which the wise use of energy can be supported from sustainable sources and

practices.

Fracking, which involves using water to fracture rocks to drill for shale gas, is causing concern over the potential environmental and health considerations related to the activity.

Bringing together the many community groups around the country, GEAI says its plan is to use information and creative communication to raise awareness of the process of fracking.

It will lobby nationally and internationally for a ban on hydraulic fracturing until independent scientific studies verify that it can be undertaken sustainably and will not result in environmental, social or economic harm.

One company, Tamboran, which has applied for a license to drill in Leitrim hopes to drill for up to 2.2 trillion cubic feet of gas over 30 years.

Widespread unregulated fracking in the USA has caused environmental damage in many states, while France has banned

RUC misconduct figures

IT was reported on February 13 that in the last three years 83 members of the RUC/PSNI were convicted of offences at internal hearings, but only 18 were dismissed or required to resign from the police service.

The rest were allowed to stay but faced sanctions such as a reduction in rank, a fine or a reprimand. Another 22 members chose to resign rather than face proceedings.

The range of offences included theft, drugs, assault, and attempting to pervert the course of justice, as well as drink-driving, sex offences, dishonesty and assault. These cover a similarly wide 1 range of misconduct among the population at large, for which members of the public face the due process of law.

Currently there are 25 members suspended from duty, and they have been paid a total of nearly £700,000 while they await the outcome of their disciplinary investigations. In one particularly disturbing case, an RUC man suspended for more than seven years

may have received some £275,000 in pay while off duty.

The figures were obtained from the RUC/PSNI's Professional § Standards Department as the result of a Freedom of Information request by the Belfast Telegraph.

'Peace' barriers increased, from 22 to 48

A REPORT from the Peace Monitoring Report in I the Occupied Six Counties in February 2012 said that fourteen years after the Stormont Agreement, the Six-County state remains "a very divided society".

The report states that: 'peace walls have increased from 22 when the agreement was signed, to a current total of 48 walls; I 'paramilitarism' remains an active threat and Six-County society is still very divided in terms of schools and housing'.

The author of the report, Dr Paul Nolan said 'violence' had declined but had not gone away.

"There is increased cooperation at the political level but there is also an increase in the number of interface barriers.

"We have seen interesting experiments in shared housing and t shared education but 92.5% of school enrolments are still in schools that are perceived to be for one community only and 90% of social housing is for single identity communities," he said.

"At times, Northern Ireland (sic) seems to be moving forward; at other times it seems in danger of lurching back into the past.

Supergrass system 'will continue'

THE British Director of Public Prosecutions in the Six-Counties said that so-called supergrass trials will

The system was widely criticised after the acquittals of 13 men, $_{\rm t}$ nine of whom were charged with the murder of UDA leader Tommy $_{\rm I}$ English. The trial lasted 21 weeks.

UVF members Robert and Ian Stewart had given evidence § against the men in exchange for lesser sentences.

The men - including former north Belfast UVF commander I Mark Haddock - walked free from court on February 23, cleared of cinvolvement in the loyalist feud murder and a litany of other charges. Of the four accused of lesser offences, only one was convicted for possessing a sledgehammer.

In delivering his verdicts, trial judge Justice John Gillen branded the star witnesses [Stewart brothers] "ruthless criminals and unflinching terrorists" and said their evidence was "infected with

He added: "The evidence before me has been too weak and s unreliable, based as it was on the flawed and unreliable Stewart testimony.

"The supporting evidence falls far short of restoring the necessary credibility to satisfy me beyond reasonable doubt as to the guilt of any of the accused on these charges

Chief Constable Matt Baggott told the Policing Board on February 29 that he was 'fully behind the use of supergrasses' and defended the use of 'assisting offenders'.

Seán Keenan remembered in Derry

THE annual Republican Sinn Féin commemoration for Seán Keenan took place on March 4 in Derry at his memorial near Free Derry

Chairing the commemoration Michael McGonigle said that had Seán still been alive ne knew very well how he would have reacted o the naming of Derry as 'UK City of Culture', o applause from the crowd.

Flowers were laid by Seán's daughters

Róisín and Noreen and wreaths were laid by Cáit Trainor on behalf of the Republican Movement and by Mary Ward on behalf of Republican Sinn Féin. A decade of the Rosary was recited by Nuala Moore and the Proclamation was read by Vice-President Fergal Moore.

Michael then called on Kevin Trainor to give the oration. Kevin gave a very passionate oration that was very well received by the audience during the course of which he said that Seán had come out of jail after the forties and fifties campaigns to find things at a very ow ebb but Seán remained staunch and helped build things up again

Referring to Derry being named 'UK City of Culture' Kevin said hat it was an insult to the Irish people the same way it would be an nsult to Latvia should one of their cities be named a Russian City of Culture. Moving on, Kevin then spoke of the necessity of Irish Freedom saying that the Irish people were perfectly able to run their own affairs and provide jobs for ourselves. He finished with a ousing "We want our country back!"

The crowd then moved off behind a lone piper to the Bloody

Sunday Memorial where a wreath was laid by Nuala Moore. On eturning to the Seán Keenan monument the National Anthem was played and the crowd dispersed

Section of Act 'repugnant to constitution

A RULING by the 26-County Supreme Court that a section of the Offences Against the State Act was unconstitutional has serious implications for many Republicans who were arrested and charged, (and indeed for the Gardaí that arrested and searched their homes) and whose cases are pending in the special non-jury court.

Five Supreme Court judges, including Chief Justice Susan Denham, uled on February 23 that section 29 (1) of the Offences Against the State Act of 1939, as inserted by section 5 of the Criminal Law Act of 1976. vas "repugnant" to the 26-County Constitution on foot of a warrant not ssued by an independent person. "Article 40.5 of the Constitution expressly provides that one's home is inviolable and shall not be forcibly entered except in accordance with the law," according to Chief Justice Susan Denham

The section has been routinely used in the past by Gardaí to search he homes of people they deem "suspects".
"A member of the Garda Síochána who is part of an investigating

eam is not independent on matters related to the investigation," Susan Denham said on behalf of the court. "The person authorising a search warrant is required to be able to assess the conflicting interests of the State and the person whose home is to be searched", the judge said.

The Supreme Court ruling was given in the case of an Algerian man, Ali Charaf Damache (45), John Colwyn House, High Street, Waterford. He was arrested as a suspect in an alleged conspiracy to murder Swedish cartoonist Lars Vilks over his drawing of the prophet Muhammad

Ex-Brit soldiers jailed for beating Irishman

IT was reported on February 19 that two ex-British soldiers were jailed having been convicted of a savage street attack on an Irishman in England. At the time of the assault the two men were serving members of the British army.

Bolton Crown Court heard how after brutally beating 24-year-old Stephen Mahon the British soldiers congratulated each other as they walked off leaving Stephen in agony on the ground.

Stephen Mahon managed to get up and stagger away but the soldiers followed him and launched another attack on him, kicking him as he lay njured on the street. Stephen Mahon was targeted in the totally inprovoked attack because the assailants heard his Irish accent. He told he court that his nationality was the only reason he was assaulted.

Simon Pierce (19) and Philip Arrowsmith (20) pleaded guilty to ttempting to cause grievous bodily harm with intent last year.

Simon Pierce already had a conviction for breaking Christopher Furner's jaw in a racist attack. Christopher Turner's face was so norrifically smashed that surgeons had to insert a metal plate in his

Pierce wasn't jailed for that attack because the trial judge was told a prison sentence would ruin his promising British army career. He also assaulted his parents, smashed his father's window with a concrete block, and head-butted a policeman



Treasurers of Republican Sinn Féin, Diarmuid Mac Dubhghlais, was arrested at his home in Dublin and held by 26-County police for two days. He was released without charge on February 16.

He tells of his experiences with the Special Branch: "On December 8, 2011 while

On December 8, 2011 While I was out driving I was forced off the road by the political police. At least 10 armed police were involved and none wore uniforms or indeed identified themselves.

"I was dragged from the car, handcuffed and thrown to the ground. I was searched as was my car. Nothing [illegal] was found so I was released. The police refused to give me any reason for this incident and refused to show ID. I have taken advice legal advice on how to proceed with a complaint and claim damages for the damage



Garda barracks. The police continued to search my house in

my absence for several hours.

Diarmuid Mac Dubhghlais pictured at a protest against the Queen of England's visit to the 26 Counties in May 2011. He was arrested and charged for the 'crime' of carrying the National Flag. The charges were later dropped.

"A week later on February 14 my house was raided by the

"During interrogation I was accused of having explosives in my possession on December 8.

This is of course a lie.
"I was held in the police station for 48-hours and for the first 30 hours I was refused a phone call and contact with my family, neither was I given access to any food. The light on the cell was left on all night – the police refused to switch it off when I asked. I was refused any bedding and in fact they put the air condition on for the whole night, denying me any sleep on my first night. Presumably this was to disorientate me.

The police removed many items from my house, mostly of a personal nature including almost €1,000 of my money (my mortgage payment).

"No inventory of items taken

has yet been given to either myself or my solicitor. I was released without charge at 11.30am on the February 16."

Oppose unjust taxation!

ON Wednesday February 29, 2012, members of Republican Sinn Féin gathered on O'Connell Street, Dublin, to participate in the protest against the Septic Tank tax, which was organised by the people of West Galway.

Buses arrived from all over the West, from Limerick to Donegal, full to capacity with people intent on showing their opposition towards this and other unjust taxes being forced upon the people by the political political establishment.

A platform was provided for A platform was provided for speakers outside Leinster House. Among the speakers was Republican Sinn Féin County Councillor for Galway Tómas O Curraoin who had this to say:

"First of all I would like to compliment all the people involved in this and in particular Padraic Ó Conghaile who started non-political this as a non-political organisation. It is equal and civil rights for all the citizens of Ireland. It's a very sad day that we have to stand outside of Leinster House to try and protect our own in such hard times.

"We forecasted back in 1973

that going into the EEC would bring exactly what we have today,

and I know today is about the water and the septic tank charges but we have to look at the whole

bigger picture in rural Ireland.
"From the turf-cutting, to the cattle in the fields, to the sheep on the mountains, to our seas that were sold away as the first sacrifice in 1973. What for? What did we get out of it? Some people got something out of it.

"We won't pay any septic tank charges. I will be asking all the people of rural Ireland not to pay the septic tank charges. I will also be asking them not to pay the household charges and I will also be asking them not to accept Irish Water that is going to take over the running of our water distribution in case people are not aware of it.

'We were told at a county council meeting in Galway last Friday that this is what would happen, that no longer would the local authorities such as councils have any control over the water.

"The polluted water that they "The polluted water that they had a fancy name for in my own county of Galway a few years ago when the kids were sick in hospital; they called it cryptosporidium. But yet the clear point of it and I will make it very clear to you what it was POISON that is what it was.

"I would like to point out about the legislation that is made across the road and the corruption that goes on inside of it. A lot of good people went into that house with the intentions of turning it around. There are a lot of good people who are in it now who spoke in our favour today but lads, the devil is inside of that house

"Whatever you do, any of you there, think every morning before you go into it because the will try and pollute you, they will try and corrupt you and they will

try and bring you on their side.

"Be on the side of the people, the majority who are suffering because of the greed of the minority that were flying around in helicopters during the Celtic Tiger and brought us to where we are today. Go raibh mile maith agaibh."

Calls for clarification on pension rule changes

LOBBY group Older and Bolder called on the 26-County Administration on January 23, 2012 to clarify changes in the rules for the State contributory pensions, and to 'launch a public information campaign on the implications of the

The organisation's director, Patricia Conboy, called on the 26-County Minister for Social Protection Joan Burton to provide those affected by the changes with "clarity, transparency, and adequate time to prepare and

She said the Minister was She said the Minister was now "flagging the possibility" of changing the way in which entitlement to the State contributory pension was calculated, moving from a mix of total number of years and yearly averages of contributions to total

number of years solely.

"What is not clear is what any of the above means for parents who take time out of the labour force to care for children; people who become ill for example with cancer and take leave to undergo chemotherapy; carers of sick/older relatives; people who work/travel abroad for a period of



Support equality for older people

(contributory) is paid to people from the age of 66 who have enough social insurance contributions. It is not means-tested. Under changes already announced in the budget and due to come into force in September, those with the minimum 10 contributions per year will see their pension drop from €115.20 to €92 a week. The new "total contributions" plan under review by the Minister would see this minimum payment for those with

10 years of contributions fall further to €76 a week.

The five-year working life

requirement is being doubled to 10 under separate measures announced as far back as 1997.

Éamon Timmins from the charity Age Action also called for clarity following comments by the Minister that she was examining the possibility of bringing forward changes which had been originally planned for 2020.
The 2010 National Pensions

Framework stated that the Government would adopt a "total contributions approach" from 2020 when calculating a person's PRSI contribution. This would replace the "average contributions" system currently

ACLU backs the secrecy of interviews at Boston College

ON February 29 it was reported that the American Civil Liberties Union of Massachusetts (ACLU) decided to support two journalists who are fighting the release of oral history interviews they conducted for the Belfast Project at Boston College, USA.

The ACLU filed legal arguments on February 29 with the US Court of Appeals for the First Circuit opposing release of the interviews, saying the journalists had a right to argue on their behalf and that the release of the information would jeopardise their integrity.

The ACLU also argued that the journalists and their subjects would be labelled informers and subjected to violence in the Occupied Six Counties in Ireland, pointing out the Irish Republican Army's (IRA) rules forbidding disclosure of information.

"The forced turnover of interview materials will convert the interviewees and their interviewers into informants," the ACLU said in legal arguments.

In December, a US District Court judge ordered Boston College (BC) to turn over the documents to the federal



government, which had subpoenaed them on behalf of British authorities investigating crimes in the Occupied Six Counties. England and the United States have a treaty that requires each of them to furnish materials that would aid in criminal inquiries.

British officials are looking

into the killing of Jean McConville, a Belfast mother of 10 who disappeared in 1972 and whose body was recovered in 2003. The IRA has admitted to killing her and claimed she was an informer.

The Belfast Project journalists, Anthony McIntyre and Ed Molony, guaranteed their sources anonymity until death. British officials were specifically interested in the interviews with former IRA member Dolours Price.

US District Court Judge William G. Young agreed to order BC to turn over materials related to the Price interview. He later ordered that other interviews be released as well. BC said that it would not appeal the ruling related to the Price interview, but that it opposed release of the remaining interviews

The report was presented to he families of those murdered by the UFF at Seán Graham's sookmakers on February 5, 1992 on the anniversary of the attack and called on British Prime Minister David Cameron to commission an independent inquiry into the Belfast murders.

The report details British Crown Force collusion in the murders of the five nationalist ATROCITY

victims – Jack Duffin (66); Willie McManus (54); Christy Doherty (52); Peter Magee (18) and James Kennedy (15). Seven others were wounded in the attack. Mark Sykes from RFJ, who was shot in the attack, which claimed the life of his 18-yearold brother-in-law Peter Magee, said the new report not only highlighted the extent of collusion but it also seeks justice for the dead.

"We...want information from him [David Cameron] around the weapons coming into the country because British military intelligence knew about them through Brian Nelson [a British agent working in the UFF]". Mark Sykes said the

Mark Sykes said the collusion has always been suspected, with eye-witnesses claiming an Ulster Defence Regiment (UDR) jeep stationed opposite the bookmakers which moved away only minutes before the murders took place allowing the killers to drive in.

In September 2010 an investigation by the Historical Enquiries Team (HET) revealed

UDA informer William Stobie thad handed the Browning pistol vused in the attack over to RUC officers, only for them to return vit to the loyalist group. The Browning pistol and an AK-47 tused in the Sean Graham's attack were both part of a transformer to the season of the season of

Relatives of all five victims, as well as friends and supporters, attended a memorial Mass at St Malachy's church before children of some of the murdered men unveiled a new memorial to them at the scene of the shootings on the lower Ormeau Road, Belfast.

Loughinisland families begin legal challenge RELATIVES of those who died in the Heights

RELATIVES of those who died in the Heights Bar shooting in Loughinisland, Co Down in 1994 are seeking to overturn the finding that there was no evidence of collusion between the Royal Ulster Constabulary (RUC) and the Ulster Volunteer Force (UVF).

Six nationalist men were shot dead when the UVF sprayed the Heights bar in Loughinisland with gunfire on June 18, 1994. No one has been convicted of the murders - 16 people arrested for questioning in connection with the attack, all were released.

Families of the victims began legal action to overturn the police ombudsman report into the murders. The relatives are challenging the report's conclusions that there was no

evidence of collusion between the UVF gang responsible and the RUC.

Lawyers and the families believe the RUC investigation was compromised because a number of those directly involved in the shooting were police informers. However, before being able to challenge the report, they are contesting a decision to refuse legal aid.

A judge has granted permission to seek a judicial review of the funding denial.

HET investigation 'whitewash'

THE family of Manus Deery, the Derry teenager shot dead by the British Army 40 years ago dismissed a report into his killing as a "whitewash".

The British Army maintain hat a soldier in a lookout post on Derry's walls fired at what appeared to be a gunman about 200 metres away, missed him and the ricochet fatally injured he teenager in the Bogside in 1972.. His family have always lisputed the Army's version and on February 17, 2012 they riticised the Historical Enquiries Team report into the cenager's death.

Manus Deery's sister Helen said she wanted the case reopened.

"With the information which they were given it is near impossible to come back with the same report that I now have," she said. "Letters with different dates, they didn't even get my mother's name right the second time round.

"They got it wrong the first time round and I made them take note of that and they came back the second time with her name still wrong. It's a whitewash."

Meeting calls for restoration of political status

REPUBLICAN Sinn Féin held a public meeting in Andersonstown, West Belfast on February 12, 2012 to highlight the ongoing protest by Republican prisoners in Maghaberry jail for political status.

Assembling at the Busy Bee, over 60 people held banners and placards calling for political status for the Republican POWs n Maghaberry jail and the release of Martin Corey.

Vice-Geraldine Taylor, Vice-President, Republican Sinn Féin, chaired the meeting and called for people to increase the pressure on the British government and on David Ford o restore political status to the prisoners

Diarmuid Mac Dubhghlais, National Treasurer addressed the meeting:

"Standing at this very spot over 30 years ago demanding political status for Republican prisoners in the H-Blocks of Long Kesh some of the people here today remember the terrible struggle being waged in the jails some of you were not even orn and others just children of varving ages.

"They were hard times; times we thought we would never see again in our lifetime. But alas we have, and are witnessing it again at first hand, so here we stand oday demanding political status once more for the Republican

POWs, this time in Roe House, Maghaberry jail in Co Antrim. The wheel has come the full circle; the more things change the more they stay the same. "The difference this time is

that a large percentage of the men who were in the H-Blocks at that time have turned their backs on the men who are currently fighting the fight that they fought 30 years ago – we thought their fight would ensure that no such circumstances would ever again

"But we were wrong and today the men in Maghaberry are suffering the same terrible conditions to win the conditions they eventually won. They are on a dirty protest, smearing their excrement on the walls of the cells they are locked down for up to 23 hours a day. No running water or toilets in the cells, the men have a bucket of water left into them in the morning. They have to eat their meals in those filthy cells and sit in them for most of the day. People have been jailed for keeping their animals in such conditions, vet the Stormont administration. (who thought they would neve

get their hands on the justice and security Department) are happy to let men endure those living conditions only a few miles down

"A few weeks ago we saw the true face of the so-called justice and security department in Stormont headed up by David Ford and backed up by Peter Robinson and Martin McGuinness etc, when Damien McKenna, a protesting POW, was refused parole to attend his father's funeral. Damien's father died suddenly and the refusal to grant him parole was mean and

despicable.
"The demand of the POWs is simple - implement the August 2010 Agreement. The demands within the Agreement are also simple: 1) an end to the degrading brutal forced strip searching, 2) and end to controlled movement and 3) their right to free association which was always the position with political prisoners.

"It is not much of an ask to

"It is not find or an acceptable treated with the dignity and respect that is their due. The actual act of forcibly stripping someone of their clothes is a

savage act which fuels the power trip of the entire apparatus of the British Establishment involved in the prison system, from the top of the British government right down the various steps in the chain to the screws who perform the act. Sick minds and hearts at work there, just like 30 years ago when physical, emotional and psychological abuse was, as it is now, the order of the day.

This time however the 'foreign foe' is joined by the 'native traitor' to keep the POWs in subjugation. But our presence here today tells them they are all failing miserably and will continue to fail because the men will not give up their right to political status and will never be subjugated.

"British occupation, and their

resistance to it, has those men in jail. Without the occupation they would be home with their families. Because the British have been here for so long people don't seem to look at their presence here as "occupiers"; but they are in occupation, in 1920 they took by force and ever since have held by force, the six northeastern counties of Ireland. Well. that occupation will be resisted and as we know resistance can take many forms. We will continue to work our own strategy of resistance until we see the back of the British government and all her baggage gone from Ireland forever.

"From here today we send "From here today we send solidarity greeting to the Republican POWs in Roe House, Maghaberry. To the two political hostages Martin Corey and Marian Price we send special greetings. Good luck to Martin in his upcoming judicial review next month.
"David Ford has no need to

go to Portlaoise prison in Co Laois to look for answers to end the protest in Maghaberry. He the answer himself in the 2012 Agreement, implement it. The POWs don't want to be in the position they are in, they don't want to live (if one could call it living) in such filthy conditions in constant conflict with the prison regime - that was why the worked on the Agreement as a means of a way forward.

"I call on all of you to redouble your efforts to put pressure on clergy, politicians, governments and anyone you think can force the British government to implement the

August 2012 Agreement.
"We demand political status for the Republican prisoners, and we demand it now, we, and the prisoners, will not give up until it is greated."

Independent Councillor condemns internment of Republican POWs

ON February 7 Independent Councillor for Newry & Mourne Davy Hyland, spoke out against the "internment and brutalisation" of Republican prisoners currently being held in Maghaberry jail, Co Antrim.

Referring in particular to Marian Price, Martin Corey and Gerry McGeough, currently being held in Maghaberry, he said that Republicans were "being unjustly held captive" that "some Republican prisoners are not receiving the adequate medical treatment they require.'

"Marian Price was granted a pardon due to ill-health following a lengthy hunger strike and subsequent force

feeding during the 1970s. Today she now finds herself being held in solitary confinement in an allmale prison.

"Martin Corey, is currently interned after his licence was also revoked by the British secretary of state. Martin Corey was released from Long Kesh in 1992 after spending 19 years in prison. In 2010 he was arrested, imprisoned and charged without

Davy Hyland said the

reasons for Gerry McGeough's incarceration was "ridiculous" as they relate to charges dating back to the eighties and said it is clear that Gerry McGeough is not receiving adequate medical treatment.

"It's clear that Republican ex-prisoners have a sword hanging over their heads and if they speak out against British occupation or if they don't toe the line they will find themselves being returned to

He cited Colin Duffy's case as a "perfect example" of this practice, claiming that Colin Duffy "found himself arrested, charged and imprisoned" in Maghaberry for almost three

years on remand chiefly because of his "strong Republican beliefs" and his vocal condemnation of the current establishment. Davy Hyland believes this to be a "clear case of internment.

Davy Hyland highlighted the on-going protest in the prison against "controlled movement and forced strip searches" and said that the recent images of Republican prisoners sporting long beards and long hair had brought "the reality and seriousness of the situation home to many people. It's an image we thought we would never see again. Ten men gave their lives in 1981 so that today's Republican prisoners would not have to suffer the same treatment they endured."

Hyland criticised politicians in Stormont for their inaction: "Some Stormont claim concerned about such cases, vet

they don't seem to be doing anything about it, except issuing the odd vague statement Despite the fact that some of them were once held captive by the British state, they clearly have short memories. They are the ones who gave David Ford the job of Justice Minister, they put him in the position, so they have a lot to answer for.

Cllr Hyland concluded by saying "As an elected representative, I personally call for an end to the torture and brutality of republican prisoners and for the full implementation August 2010 agreement which would bring this crisis to an end."

POA call for 'rethink' on strip-searching

THE prison officers' union in the Occupied Six Counties called on February 23, 2012, for a rethink on the routine use of full body searches in iails in the Six Counties.

Finlay Spratt of the Prison Officers Association (POA) believes the practice can never be dispensed with completely. but is angry at the lack of progress on introducing new technology.

POA described the justice minister's failure to introduce state-of-theart search equipment as "completely unacceptable" – claiming the delays were causing unnecessary tensions within our prisons.

"There's no excuse for not introducing the type of search equipment used in airports," he said. "If these new machines are good enough to stop people bringing things on to airplanes with hundreds of people on board then they should be adequate for establishments.

The Prison Service in the Occupied Six Counties currently undergoing a radical overhaul following recommendations made by review panel.

A spokeswoman for the Prison Service in the Six Counties said "alternative technologies" to body searches were being explored including the possibility of low-dose Xray technology.

ON February 17 Marian Price was moved from

Maghaberry prison to at Hydebank outside

Monsignor Raymond Murray, the former Armagh women's prison chaplain, said British secretary of state Owen Paterson's decision to revoke Marian Price's license had of the past for echoes

nationalists.
"This is a form of internment," said Monsignor Murray, "I am just shocked that the secretary of state wouldn't be aware of how seriously nationalist people look on internment. We thought it had all ended and here it is coming under a form of revocation, revoking a license.

"He would have to explain to us and explain the process of law as regards Marian Price. In any way has she broken the law? That would have to be provided but it is not provided by shoving her into prison on a pretence in an unjust way.'

OnFebruary 26 Suzanne Breen reported in the *Sunday* newspaper that ex-Republican women prisoners were to mount a protest in support of Marian Price.

Marian Price was moved from the top-security Maghaberry jail, where she had been held for nine months in solitary confinement, to Hydebank female prison due to a deterioration in her health.

Marian Price, who is suffering a range of health problems, was on hunger strike in Brixton jail in the 1970s and was forced-fed for over 200

days along with hers sister Dolours.

Detention of Marian Price 'internment'

Female Republicans held in both the old previously and Maghaberry Armagh jail - along with nonpolitical nationalist women will mounted a protest in Belfast before handing a letter into Stormont Justice Minister David

Ex-INLA prisoner, Gina McElroy said that Marian Price 'is being detained without charge so she doesn't even have a release date.'

Last year Marian Price was charged with holding a statement for a masked "Real IRA" man at an Easter commemoration in Derry and with allegedly providing a mobile phone "for terrorist use"

She was granted bail by the courts on both charges but Secretary of State Owen

Paterson withdrew her licence Marian Price's lawyers claimed he had no right to do so as she'd been granted the royal prerogative of mercy when freed from jail - weighing five stone and suffering from tuberculosis – in 1980. The British government variously claim this pardon has been lost or shredded.

On Saturday February 25 a demonstration was held in Guildhall Square in Derry to highlight the ongoing internment and torture of Marian Price.
Former MP Bernadette

Devlin-McAliskey Monsignor Raymond Murray will address a meeting in St Paul's GAC, 98 Shaws Road, west Belfast on International Women's Day March 8 at 7.30pm against Marian Price's continued detention.

Clonmult Martyrs commemorated in Cork

THE 91st Anniversary Clonmult Martyrs commemoration took place in Midleton on Sunday, February 19.

The commemoration assembled at 2.30pm outside the Courthouse and proceeded to St. John the Baptist Churchyard where the proceedings were chaired by Donal Varian. After welcoming everyone Donal asked Tony Horgan to lay a wreath on behalf of Republican Sinn Féin on the grave of Volunteer Deasy and a decade of the Rosary was recited.

The Commemoration then continued to the Republican Plot, Holy Rosary Churchyard. Where Donal said a few brief words before asking the following to lay wreaths. Donal Dennehy laid a wreath on behalf of the families of the Clonmult Martyrs on the Republican Plot. Veteran Republican Every John Mangan laid a wreath on the grave of Commandant Diarmuid Hurley OC, who was killed by Crown Forces three months after his comrades. Mary Ward Republican Sinn Féin, laid a wreath on behalf the Republican Movement.

Donal then spoke about the sacrifice the Clonmult Boys, the men and women of 1916 and the generations since have made.

He then introduced Mary Ward of Republican Sinn Féin to give the oration. She said:

"The strongest common bond uniting mankind is love of liberty and a willingness to sacrifice anything to achieve it. From man's earliest record to the present time the names that glow forth from the yellowed pages of history are not the names of rulers who controlled men's lives, not the great orators and poets who stirred men's hearts but the simple honest men of

every race. "Throughout history's pages there is no story so sorrowful yet so grand as Ireland's long struggle for freedom. Indeed no country has laboured so long and diligently, has suffered so much and failed so often and yet had the strength, the courage and the character to try again. The dying words of Robert Emmet 'When my country takes her place among the nations of the world, then, not till then, let my epitaph be written'. The glorious words of Allen, Larkin and O'Brien 'God save Ireland' were spoken before a hostile tribunal for a cause which they knew in their day at least was doomed to failure. They failed but they inspired other to follow in their example. And so it was the Fenians inspired the men and women of 1916 and they in turn inspired the men and women of the 1919-1922 period. "During the 1919-1922 period

"During the 1919-1922 period the IRA were well aware that they faced the might of the British Empire, a far more superior and equipped enemy, so they changed and adapted their tactics. They perfected the art of guerrilla warfare; a method which was later employed by freedom fighters the world over from Kenya to Algeria. When the men from East Cork went to the farmhouse in Clonmult, they had witnessed the

cruelty of the Black and Tans and Auxiliaries, they had attended the funerals of Tomás Mac Curtáin murdered in front of his pregnant wife and children and of Terence Mac Swiney following a long hunger strike in Brixton prison. They had witnessed the burning of Cork city, yet they pledged to fight for the freedom of Ireland, to uphold the Republic proclaimed in arms at Easter week and ratified by the Irish people in open ballot in 1918.

"In January 1921 the active service unit of the fourth battalion of the first Cork brigade took possession of a disused farmhouse in a secluded position overlooking the village of Clonmult. Commandant O'Hurley decided to ambush a military train at Cobh junction on Tuesday Feb 22nd 1921. He set out to make the necessary arrangement accompanied by Vice-Commandant Joseph Ahern and Captain Patrick Whelan.

"On Sunday, February 20 Michael Desmond and John Joe Jovce left the farmhouse to go to a Joyce left the farmhouse to go to a nearby spring when they noticed the house was surrounded by British forces. They both died as they fought to return to the house, but not before they had warned those inside of the situation A sortie from the farmhouse was attempted in the hope that assistance could be organised from the local company in Conan. With the farmhouse burning around them, an attempt was made to escape, but many of the volunteers were killed in a hail of bullets from the Black-and-Tan forces who had come to re-enforce the British regulars. Of the prisoners taken, two were later executed, five others had their sentences commuted and one, Captain Higgins, who had been shot through the mouth, had his life spared by the advent of the truce in July.

"The Ireland of today is a

product of a counter-revolution, which succeeded in over throwing the 32-County Republic of 1916 and the all-Ireland Dáil Éireann of 1919. The forced partition of Ireland in 1922 was brought about by the threat of an immediate and terrible war by England and by the collaboration of erstwhile Irish Republicans. The more recent Stormont agreement of 1998 updated and secured English rule in the Six Counties, again with the collaboration former Republicans. In helping to bring all of this about these lost souls, we are told, had been infiltrated by English agents. There is scarcely a doubt about this but they were already infiltrated from deep within by an overweening pride and arrogance, which has been the downfall of many before. No Irish patriot died for a new Stormont or a new style English crown police force. But some are so conceited in their self-importance that they

think they can ignore this truth.

"There is also a more ominous, more menacing and longer-term objective behind this

holy alliance of English imperialism and Irish collaboration, it is to extinguish forever Irish Republican resistance to English rule in our country, but there are still faithful republicans in Ireland, north and South. "There is so much in the Ireland of today which is an affront to the noble ideals of our patriot dead. The dishonesty, the lies, the deceit, the mercenary and shameless selfishness and greed in public life are the very anti-thesis of the generous and honourable ideals of our patriot dead. The contrast is obvious and unmistakable.

"Not only have we the unjust and undemocratic partition of our country, we also have an ever widening gap between the rich and the poor, the haves and the havenots. This has not happened by any accident or misfortune. This is the result of deliberate and premeditated policies implemented under the cover of a clever smoke screen provided by well-paid and unscrumlous spin doctors.

unscrupulous spin doctors.
"The education system has been fundamentally re-shaped to train workers for the multinational enterprises which are now more

powerful than governments and for export to Australia and elsewhere. Just this week the government was calling for the speeding up of apprenticeships from FAS, they can't get rid of our young people quick enough, our best and our brightest. "Even in the universities, the

classics, the Irish language, Irish history and Irish and Celtic studies have been downgraded, some would say virtually abandoned. Is this any wonder when the Smurfit's and the O'Reillys now provide considerable finance for some of these colleges? Skills are certainly important, but the schools and colleges should also be helping parents to imbue their children with standards and values for life. They should also be helping students and pupils to appreciate and develop their Irish identity, as well as to develop their critical faculties, their capacity to think things through, to assess and appraise and evaluate all that they will have to encounter in life. The politicians and the bosses of finance and industry, however, prefer to keep young people malleable and compliant, a prey to advertising hype disinformation.

"The travesty of democracy, which we witness daily in our country, is a well-managed spectacle of mockery and deception. From the local councils and shady deals to the mock theatre of Leinster House and Stormont, to the mandarins of Westminster and the European Union, and the invincible looking power of the United States and Britain backed by the muscle and might of international capitalism, the ordinary, decent, hardworking people of Ireland in town and country are being exploited, and the weakest and most vulnerable, the old, the ill, the incapacitated, the disadvantaged many young people who come from our schools barely literate are the most exploited of all We have ever-

quite vicious and ruthless.

"Both states fail to protect their citizens from exploitation by trans-national capital and manipulative commercial interest, from drug pushers and alcohol producers, as well as from British spies and agents. Politicians get into power backed by the wealthy groups and individuals and then they are the prisoners of these people. Two examples of this are the compliant hire of Shannon airport to the US administration and the revelations that Irish hospitals have to pay twice what they pay in Spain for essential drugs manufactured by companies

rising levels of crime, some of it

in Cork.

"In a democratic system, power rests with the people; in Ireland today there is collusion and a conspiracy among the wealthy, the politicians and sections of the media to accumulate and share the spoils at the expense of cordingry people.

the expense of ordinary people.
"Yet the ordinary people have
to pay for the bank bail-out and
the excesses of these gangsters
who are actually being paid up to
£200,000 by NAMA, eight times
more than the average industrial
wage.

wage.

"The priorities in public life in Ireland are the priorities of rampant capitalism and this is facilitated and made possible by politicians whose only interest is power for powers sake. Meanwhile we have a plethora of tribunals, enquiring into all kinds of misconduct and costing millions of euro each year. A lot of fraud and corruption has been unearthed, but nobody ever seems to be prosecuted for misdeeds. Ads since shame and embarrassment are in short supply; these tribunals serve now as expensive and protective shockabsorbers, where wrong doing can be reluctantly exposed while even more corruptive practices proceed

apace.

"We have lost our manufacturing base, our fishing rights, mineral rights and financial independence to the EU and the infamous Troika. No the Ireland of today is not a pretty sight. English imperialism is alive and well and holds six of our counties in direct occupation. This same power infiltrates the other 26 counties and dictates its terms to them. In the whole country, there is a basic affliction which is a lack of principle, standards, value and

morality. Both states are in hock to English imperialism, neo liberal capitalism and its free market and culture of greed.

"The great and almost daunting, challenge to us Irish Republicans is to confront and change all of this. In the 1790's Wolfe Tone and his comrades faced a similar challenge. They rose to the occasion in every sense of the word. They formulated their plans and they confronted those who were the exploiters of the Irish people, foreign and domestic.

"The hallmark of their approach was that they sought no personal gain for themselves, their rallying cry was liberty, equality and fraternity and they gave generous and unstinting service. Then, they made their appeal to the broad mass of the Irish people, Protestant, Catholic and Dissenter, and they organised their generation. They were truly revolutionary and their message struck a chord with the common people. The broad mass of the people always retain and cherish a yearning for freedom based on

"We are not alone in the task we seek to accomplish. We have many active supporters who are not present here today. We have our Republican prisoners, who are also a source of inspiration to us as they keep their lonely vigil for Ireland, and to whom we send greetings from this historic spot. We have many friends and sympathisers throughout Ireland and we have active supporters abroad. All share with us our vision of a New Ireland – ÉIRE NUA, a New Democracy of four provinces with regional, local and community self-government. For us the model is neither Boston nor Berlin. For us the task is to restore the historic Irish nation on the basis of liberty, equality and fraternity, and to put the people of Ireland in charge of their own destinies.

"We will continue to work regardless of the defections of recent years and regardless of the sinister efforts by certain elements in the Establishment and in the media to denigrate our work and to smear our good name.

to smear our good name.

"In the Six Occupied Counties, the nightmare of the nationalist people continues. In some areas it is particularly acute and communities live in continual fear of attack. The Stormont Agreement has not brought reassurance to the Unionist people either. And neither Westminster nor Leinster House can bring peace with justice, because both of these institutions operate to a different agenda. As Wolfe Tone said of the Ascendancy of his time "They see Ireland only in their rent rolls, their places, their patronage and their pensions".

"The ÉIRE NUA programme

The EIRE NUA programme for a four province federal Ireland represents a modern progressive project based on the original ideas of Tone. It is the surest guarantee of a secure place in Ireland for all our people.

"I will conclude with the words of General Liam Lynch 'We have declared for a Republic, We will have no other law."

The importance of the 1916 Proclamation

AS we approach the year 2016, the 100th anniversary of the Easter Rising which took place in Dublin in 1916, it behoves us to look closely at what exactly we commemorate when we gather at gravesides every Easter.

The main and most important part of the commemoration should be reading the of the Proclamation, since it bequeaths to us our nationality, identity and ownership of our country, all 32 counties. This is stated very clearly in the first paragraph with a clear message as to how liberation of our occupied country will be achieved.

The paragraph begins: IRISHMEN and and IRISHWOMEN: In the name of God and of the dead generations from which she receives her old tradition of nationhood Ireland through us, summons her children to her flag and STRIKES FOR HER FREEDOM.

These last four words constitute a "declaration of war" in any language.

There follows a list of those organisations who have pledged their allegiance to armed struggle for freedom, namely, the Irish Republican Brotherhood, the Volunteers, the Irish Citizen Army and these coupled with support from America and allies in Europe, prepared for a war of liberation. The war was commenced in full confidence of victory.

Proclamation The continues with the words "until our arms" have brought about the opportune moment for the establishment of a permanent National Government representative of the whole people of Ireland, the Provisional Government "hereby constituted" would administer the civil and



affairs of the military Republic in trust for the people.

This is a very important statement as it defines Irish Republicans as those who support armed struggle and the 32-County Provisional Government set up in 1916.

The Proclamation closes with the words: "We place the cause of the Irish Republican under the protection of the Most High God, whose blessing we invoke upon our arms, and we pray that no one who serves that cause will dishonour it by cowardice, inhumanity or rapine.

"In this supreme hour the Irish Nation must, by its valour and discipline, and by the readiness of its children to sacrifice themselves for the common good, prove itself worthy of the august destiny to which it is called.'

This declaration of a WAR OF LIBERATION was then signed on behalf of the Provisional Government by:

Thomas J Clarke, Seán Mac Diarmada, PH Pearse, James Connolly, Thomas McDonagh, Éamonn Ceannt and Joseph Plunkett.

These seven leaders of Óglaigh na hÉireann knew as they signed this document that they were signing their own death warrants, and so it came to pass. All seven were taken out and executed by a firing squad from the bloodthirst British forces of occupation.

Republican Sinn Féin stands over the Proclamation of 1916. We pledge to work its complete implementation using whatever means necessary for the removal of the murderous British forces who continue their reign of terror today in the Six Occupied Counties of our country.

Khader Adnan ends hunger strike PALESTINIAN prisoner Khader Adnan ended his

66-day hunger strike on February 21 after Israel agreed to release him in mid-April provided that no 'significant" new evidence is found against him. No guarantees.

Under a "deal" struck by the Israeli authorities and signed by one of his lawyers, Khader Adnan stands to be freed three weeks earlier than planned after conducting the longest ever hunger strike by a Palestinian prisoner. This means the detention period will end on April 17 instead of May 8. Khader Adnan's case had triggered protest demonstrations in the West Bank and Gaza, and token hunger strikes by Palestinian

prisoners in Israeli jails. It had also prompted mounting international

On February 15, 2012, Geraldine McNamara, National PRO, Republican Sinn Féin again condemned the Israeli administration for refusing to act in the case of Khadar Adnan, then in his 60th day of hunger strike. She likened Khadar Adnan to Bobby Sands and said that "Too many stood idly by then and we should be ashamed that no international body has succeeded in calling on Israel to end

this tragic situation."

Khadar Adnan's hunger strike focused fresh attention on the practice of administrative detention under which Palestinians are held without charge or trial and on the basis of secret evidence which can be shown to a military court but not to the defendant or his lawares.

The Israeli human rights group B'Tselem said on February 21 that 309 Palestinians were currently held under the procedure, which it said violates the rights to liberty and due process. Furthermore, in December 2011, over 60 percent of those held had had their orders where ded excellent expectations the procedure of the procedure to the procedure of the procedur

extended at least once, according to the rights group.
Richard Falk, United Nations Special Rapporteur on Palestinian human rights, said on February 22: "It should be noted that on matters of principle, Israel gave not an inch: even in relation to Mr Adnan, he will remain in captivity and will be subject to the "legal" possibility that his period of imprisonment could be extended indefinitely; beyond this, Israeli authorities conceded no intention whatsoever to review the cases of the 309 other Palestinians who are presently being held under the administrative detention

procedure.

"These include one prisoner held for more than five years, and 17 others for periods of two to four years. Israel did not even agree to a review of their excessive use of administrative procedure, an approach that, at best, is supposed to be reserved for true and credible emergency situations.

"...administrative detention is seemingly used to harass and intimidate militant opponents of an oppressive occupation - an occupation that has continued for 45 years, and is aggravated by continuously appropriating Palestinian land and water for the benefit of settlement expansion, while disrupting and cleansing long-term Palestinian residency." Red Cross attempts entry to Baba Amr for third time

THE International Red Cross is to attempt to deliver aid to the devastated Baba Amr district of the Syrian city of Homs for a third day on March 4.

A spokesperson said the Red Cross would resume negotiations with officials who barred its convoy on March 3.

The seven-lorry Red Cross aid convoy spent a second night in Homs after being blocked from entering Baba Amr on Saturday,

despite having been initially given permission from the government.

"We really don't know how many people are still in there. It's
all a bit of a mystery to us." Seán Maguire said the ICRC had been "disappointed" not to be able to enter Baba Amr for two days

ning. Syrian state television broadcast pictures from inside Baba Amr that show massive destruction, with no power and little food, water

and medical supplies.

In an address to the UN General Assembly on Friday, Secretary-General Ban Ki-moon said the international community had failed in its duty, and inaction had encouraged Syria's leaders in their repression of civilians. He said it was time for the international community to speak with one voice.

The bodies of veteran war reporter Marie Colvin and French photographer Remi Ochlik arrived in Paris from Syria on March 4, ten days after they were killed in a rocket attack in the rebel Baba Amr neighbourhood of the besieged city of Homs. French reporter

Amr neighbourhood of the besieged city of Homs. French reporter Edith Bouvier of Le Figaro newspaper and a Sunday Times photographer Paul Conroy were wounded in the same attack. Paul Conroy was smuggled out of Syria into Lebanon on February 28. He told the BBC that what was happening in Baba Amr was "systematic slaughter". He described the scenes in Homs from his hospital bed in the UK. "Tve done a fair few wars, I've never seen anything on this level," he said

On March 3, Nick Meo reported from Guvecci on the Turkish-Syria horder.

Humanitarian conditions in Idlib province have worsened in the past few weeks. Food is in short supply — with many people surviving off dry bread — and power cuts are frequent. There are few doctors because, say the rebels, the regime has targeted them so that

fighters and demonstrators cannot receive treatment.

What was clear...was that some of the main rebel enclaves in northern Syria have been overrun, in an area which had been spoken of as a possible rebel stronghold where the Free Syrian Army (FSA) could be trained and equipped.

"It is very dangerous now," said Wasim Sabbagh, 35, a spokesman with the Free Syrian Army. "The Assad forces are

'State of women's jails shames Britain'

BRITAIN should be "aghast and ashamed" at the way it is treating some of the most disturbed women in its jails where levels of self-mutilation remain shockingly high, the chief inspector of prisons said last night.

Nick Hardwick said in the *Independent*, March 1 that he had been kept awake at night by scenes he had seen at Styal women's prison and said too little had done since a groundbreaking report prison and said too little had done since a groundrocking report
sparked by the deaths of six women at the jail between 2002 and
2003. He cited the example of one private prison near London which
recorded more than seven cases of self-harm a day, and the case of
one woman who had harmed herself 93 times in one month.

On February 11, Clive Chatterton, who spent 37 years working
in prisons and was greaters of Stull's women's price in Cheshies

in prisons and was governor of Styal's women's prison in Cheshire in prisons and was governor of Siyai s women's prison in Chesnire before retiring three months ago, said that urgent reform is needed and called for the government to vigorously pursue alternatives to jail for disturbed women. He called a "warts-and-all review of the aims and intent of the use of custody"; an immediate end to short sentences; more women to be transferred to secure mental health units where they can receive the right care; and alternatives to prison that roughly he forded by the "three" "continue that would be forded by the "three". that could be funded by the "huge" savings that would be derived from not jailing the third of women currently imprisoned for minor offences and added that he had "never come across such a concentration of damaged, fragile and complex-needs individuals".

British faces revolt over 'secret justice' expansion

THE British government is facing widespread revolt over plans to expand "secret justice" laws to ensure controversial court cases and inquests can be held behind closed doors.

Under the plans "closed material" will be allowed to be heard in secret in civil courts if it is deemed to have the potential to "damage the public interest"

the public interest".

Security services support the significant extension as they feel in the past they have been unable to defend themselves properly in open court for fear of disclosing sensitive intelligence.

Justice Secretary Kenneth Clarke is anxious to prevent a recurrence of the multi-million-pound compensation payments to 15 former inmates at Guantánamo Bay in 2011 and will defend the Government's Green Paper proposals when he faces Parliament's ionit committee on human rights next week ioint committee on human rights next week.

"An innocent man, American Indian Leonard Peltier was wrongfully convicted in 1977 by the United States government. He has served 36 years in prison despite proof of his innocence.

"In the early 1970s, the Federal Bureau of Investigation (FBI) supported the corrupt Sioux Tribal Chairman Dick Wilson (on the Pine Pidge Indian Reservation in South Dakota) by providing arms.

supported the corrupt Stoux Tribat Chairman Dick wilson (on the Pine Ridge Indian Reservation in South Dakota) by providing arms and information to Wilson's vigilantes. Anyone who opposed Wilson or who sought to advance Indigenous rights was targeted for abuse or worse. "During a three-year period, reservation residents were terrorized. Hundreds of people were seriously injured and over 60 people were murdered.

'The American Indian Movement (AIM) is committed to uniting all Native Peoples in an effort to uplift their communities and promote cultural pride and sovereignty. In 1975, frightened Pine Ridge residents called upon AIM for protection. Leonard Peltier was

one of the AIM members who answered the call.

"On June 26, 1975, FBI agents drove onto private property (where AIM members were known to be camped), allegedly in pursuit of a man accused of stealing a pair of boots. "For unknown reasons, a shoot out began. When the skirmish ended, the two FBI agents were dead. A young Native American named Joe Stuntz also lay dead, shot through the head by a sniper bullet.

"In a case developed by the FBI, Leonard Peltier was targeted for prosecution along with two other men. At trial, Leonard Peltier was not permitted to adequately defend himself. "His actions being no different than those of his co-defendants - who were tried separately and found not guilty by reason of self-defense - Leonard Peltier was nevertheless convicted and sentenced to two life terms. The US government had succeeded in preventing critical evidence from being heard by the jury, presenting false evidence, and otherwise manipulating the trial to cause the conviction.

"The US courts have acknowledged that Leonard Peltier was

convicted on the basis of fabricated and suppressed evidence, as well as coerced testimony, but refuse to grant him a new trial. He has been repeatedly denied parole as well despite his being a model prisoner and having met the criteria for release. Peltier is 67 years of age and in poor health. And still he waits for justice.

At the event, Fidel Castro spoke about current affairs, praising Latin American students for 'standing up for their right to free education'. Fidel Castro handed over the presidency to his brother Raul in 2006, and has kept a low profile since.

IUF condemns Turkish government

TRADE union rights in Turkey have long been a cause of concern for the global trade union movement.

As a result of legislation imposed by the military regime in 1980, workers in Turkey have been denied their basic rights to freely organise in trade unions, to bargain collectively and to take strike

organise in trade unions, to bargain collectively and to take strike action. Despite government commitments to uphold international labour standards, workers' rights remain legally restricted and ruthlessly repressed by employers and by the government.

The IUF and its affiliates in Turkey are deeply concerned by the government's draft law that imposes a three percent national sector membership threshold for a trade union to meet before that union can legally engage in collective bargaining with any employer in the sector. The draft law denies to workers the fundamental right to organise and bargain and would cause many unions to be stripped of their collective agreements.

The IUF and its member organisations call on the Turkish

their collective agreements.

The IUF and its member organisations call on the Turkish government to immediately revise the draft law to bring it into compliance with ILO Conventions and international labour standards. The IUF will continue to support union action, in Turkey and abroad, to ensure that trade union rights are fully respected in Turkey and accessible to all Turkish workers.

Sile Heneghan died on February S at the age of 102. She was born in Tontaleva, Leenane, about six miles into Co Mayo from that town.

Síle's earliest recollection was of British troops and Black-and-Tans raiding her parent's home after "wanted" Volunteers had

escaped out the back.
Sile worked in Thurles in the early 1940s and joined Cumann na mBan. A local Volunteer, Paddy O'Connell was then a Republican

prisoner serving 20 years penal servitude in England. In the mid 1950s she emigrated to Boston and joined many organisations Irish-American

She also wrote to the Republican prisoners in Portlaoise jail and developed a correspondence with Dan Hoban

In 1983 she came home, settling in Galway city and was supportive of every Republican activity since then, locally and nationally. She spent the latter years of her life in the Blackrock Nursing Home where the staff and her family organised a wonderful party for her on her 100 birthday

Sile was laid to rest in the graveyard in Leenane facing the beautiful Killary Harbour after a concelebrated Mass with visiting French priests and the local parish priest.

The Tricolour and Cumann na mBan flags draped her coffin. A Guard of Honour comprised of

Cumann na mBan and Sinn Féin Poblachtach accompanied the coffin as it was carried by family and friends and members of Sinn Féin Poblachtach across the road to the cemetery.

Her friend of many years Dan

Hoban gave the oration who first sympathised with Sile's family. He continued: "We are here to lay Sile to rest but we are also here to celebrate a life dedicated to the Irish Republican cause, because Sile Heneghan gave a lifetime in Cumann na mBan to the fight for the freedom of her country.

"As we lav her here to rest we know that throughout her life and right up to the final moment she was loval to the Republican cause and she had only one belief and that belief was that Ireland would be liberated and free one day from the centre to the sea

vears old when the men of Easter week, Pearse and Connolly, MacBride, her own county man, and all those who were shot by the firing squad on Easter week, and she had a great memory of that and she remembered every bit of

"In 1956 she emigrated to Boston. She wasn't too long there Boston. She wasn't too long mere when she linked up with another great Mayo man, a man who left this country in 1938, George Harrison who said when he got into America that he would never set foot in Ireland again until she was free, who worked tirelessly over all the years until his death at the age of 99 for the Republican cause

Síle linked up with him and another Tipperary man who had fought with Seán Treacy, Dan Breen and a man called Michael Flannery whose name was a household one in America

"My first contact with Sile Heneghan was in 1972 when I was in Portlaoise prison. When she came home on holiday she visited me in Portlaoise prison. She took a silver bracelet out of her pocket and she handed it across through the mesh to me. That bracelet had my name and Political Prisoner engraved on it and I have it to this day and I will always treasure it

"Sile said to me: 'There has come a generation of young Irish men who are greater than any generation before and I think they will do the iob'.

"But alas it wasn't to happen because Sile lived through the death of Bobby Sands and all his comrades. She carried her black flag at the processions as each hunger striker died. She visited Wolfe Tone's grave every year for the commemoration in

Bodenstown and she remained loyal right throughout. She saw the death of Frank Stagg and Michael Gaughan and she was very saddened as she had seen all this before. She had seen the hunger strike of McNeela and Darcy, a Galway man and a Mayo man. Síle was in digs with Seán McNeela's sisters in Tipperary and they were in Cuma mBan together.

"That was Sile Heneghan, true to the bitter end. A great person, a great soldier and a great Republican. Sile, you were a true servant to the Republican Movement, to everything that was good in this country of ours. When we were there and thought we had no hope you gave us inspiration.

"He was our friend and fellow traveller who prove takes his

traveller who now takes his rightful place in the ranks of our departed Fenian stalwarts. He leaves us with fond memories, but, also with a void that will never be filled. Farewell dear

"Brian's unique gifts as an artist were given selflessly to aid the cause of a free Ireland. His paintings were used to highlight paintings were used to highlight the plight of the Hunger Strikers in 1981 as well as every other facet of the ongoing struggle against British rule in Ireland. Famously in December 1983 he was responsible for an electronic sign in New York's Time Square sending out Christmas greetings to Republican prisoners. Brian took great pride in the fact the British

Ambassador was questioned over the sign. Brian used his artwork as a weapon against imperialism and in defence of the men and women of no property. Among his last works were cartoons in opposition to the visit by the Queen of England to the 26 Counties in

May of last year.

"In June of last year he wrote an open letter to the Lord Mayor of Belfast to protest at one of his ster artworks, commemorating eobald Wolfe Tone and the 1798 Rising, being hung in Belfast City Hall. Brian saw this as merely an attempt to distract from the fact that Belfast and the rest of the Six Counties were occupied by British forces. In his own inimitable style Brian finished his letter by declaring: 'When the Belfast City Hall is

located in a united Ireland, not the United Kingdom, I would be honoured to see my artwork displayed. Until then, I request that it be taken down. Moving the picture of the Queen of England from one wall to another does not in any way make Belfast part of a United Ireland. I object to my artwork being used to pretend otherwise.'

"Brian's involvement in the cause of Ireland stretches out over five decades; he was a founder member of Irish Northern Aid (NORAID) in 1972 and worked with the *Irish People* newspaper for almost 20 years. In 1986 he rejected the attempts of a reformist leadership to hijack Republican Movement and was among the founders of Cumann na Saoirse of which he remained an officer up to his death.

"Brian had a deep

understanding and knowledge of Irish history and was a living link with previous generations of Irish Republicans who fanned the flames of revolutionary Republicanism such as Michael Flannery, Joe Stynes and George Harrison. Brian very much followed in their footsteps and ensured that the torch was passed to a new generation. Brian Mór was a friend, comrade and mentor

to succeeding generations of activists in the cause of Irish Freedom in the US and Ireland over many years and was always willing to give freely of his time and experience.

"Brian leaves behind a gap in

Brian leaves beining a gap in the ranks but his legacy of unflinching loyalty and tireless commitment to ideal of the All-Ireland Republic of Easter Week Ireland Republic of Easter Week is an inspiration to his friends and comrades on both sides of the Atlantic. In the words of Thomas Davis: "The rudder of our ship and the property of the pro

Brian Mór was buried in New Jersey on February 24. At the graveside Pat Williams of the National Irish Freedom Committee read a statement from the Irish Republican Movement in Ireland.

The eulogy was delivered by his colleague in Radio Free Éireann, John McDonagh who paid tribute to the life and legacy of his friend.

"Bernie has left behind a treasure trove of artwork, cartoons and writing. He has laid the foundation for future generations to follow – and we will be forever in his debt.

"Although a born and bred

New Yorker, Bernie never forgot his family ties to Donegal, and at the *Irish People* newspaper, found the perfect place to blend his Fenian passion with his artistic skills.

"One of our finest moments was standing in the middle of Times Square on December 16, 1983, watching the electronic sign board send Christmas Greetings to Irish Prisoners of War. Our second finest moment was enjoying the stir it made. CAMPAIGN IN SIX COUNTIES HALTED

50 Years Ago

THIS month we carry the entire press release from the IRPB re the halting of the 1956-62 campaign, dated February 26, 1962: 'To prepare a more favourable situation'. (The last paragraph is the most important. It was quoted in Westminster, Stormont and Leinster House)

The following statement was released for publication by the Irish Republican Publicity Bureau at 19.40 hours on February 26, 1962: To the People of Ireland

THE Leadership of the Resistance Movement has ordered the termination of the Campaign of Resistance to British Occupation launched on December 12, 1956. Instructions issued to Volunteers of the Active Service Units and of local Units in the occupied area have now been

carried out. All arms and other material have been dumped and all full-time active service

Volunteers have been withdrawn.

The decision to end the Resistance Campaign has been taken in view of the general situation. Foremost among the factors motivating this course of action has been the attitude of the general public whose minds have been deliberately distracted from the supreme issue facing the Irish people – the unity and freedom of Ireland. Other and lesser issues have been urged successfully upon them and the sacrifices which would win freedom in the political, cultural, social and economic spheres are now stated to be necessary to bolster up the partition system of government forced on the Irish people by Britain forty years ago.

SECONDARY ISSUES

This calculated emphasis on secondary issues by those whose political future is bound up in the status quo and who control all the mass media of propaganda is now leading towards possible commitment of the people of the 26 Counties in future wars. The Resistance Movement stands firmly against any such course of action while Ireland is unfree and will use all its resources towards restoring in full to the Irish people their sense of national

For over five years Irish freedom-fighters have fought against foreign occupation, native collaboration and the overwhelming weight of hostile propaganda. Supported loyally by the Republican people of the Six Occupied Counties they have faced fantastic odds. 5,000 British regular troops, 5,000 territorials, 12,500 B-Specials, 2,000 RUC, 1,500 speciallytrained Commandos and sundry security guard forces totalling close on 30,000 armed men bar the road to freedom. Their considerable resources have included armoured vehicles, liberally supplied by the British government, heavily fortified strong-points and the most modern war equipment.

TORTURE AND TERROR

Terroristic tactics against the civilian population, draconian laws, imprisonment without charge and trial, torture-mills to force "confessions" from prisoners, long and savage penal servitude sentences, the shooting down of unarmed people at road-blocks and threats of even sterner measures including floggings and hanging have all been employed to maintain British rule in the Six Counties.

The leadership of the Resistance Movement wishes to pay a long overdue public tribute to all the loyal Irish people of every class and creed who gave support – whether in the form of billets, transport, intelligence, funds, munitions or even encouragement – and to all who had the moral courage to speak out in private or in public in defence of the men fighting for Ireland. In future an even greater volume of support will be needed so that the Cause dear to the hearts and minds of all who have actively contributed to the Resistance Campaign of 1956-62 will ultimately triumph.

savage sentences since imposed for technical offences culminated in the imprisonment of a young freedom-fighter from Co Derry for eight years. In the teeth of such provocative action by those whose aim appears to be civil strife in the 26 Counties the discipline of Irish Resistance fighters in adhering to their instructions over the entire five-year period has been magnificent.

MILITARY TARGETS

When repeated warnings by the Resistance to ceases bearing arms against their own people were disregarded, the RUC and B-Special Constabulary were listed as legitimate military targets. The international provisions governing belligerent status including the wearing of means of identification, the carrying of arms openly and being under the control of responsible officers have been observed by the Resistance Movement but in no case has the enemy recognised the status of the men fighting for their country other than as

During the five-year Campaign over 600 operations against enemy patrols, strongpoints, communications, transport and civil administration have been carried out at enormous cost to the enemy. Casualties inflicted total six killed and 28 wounded. (This includes British soldiers, B-Specials, RUC and Commandoes). In addition four members of the Crown Forces – apart from British military, naval and air force personnel for whom figures are not readily available - were killed other than by Resistance action.

In the same period the Resistance suffered two killed in action and seven killed accidentally. Also a Sinn Féin organiser was murdered by British Crown Forces near

ETERNAL HOSTILITY

The Resistance Movement remains intact and is in a position to continue its Campaign in the occupied area indefinitely. It realises, however, that the situation obtaining in the earlier stages of the Campaign has altered radically and is convinced that the time has come to conserve its resources, to augment them, and to prepare a more favourable situation. The policy of not taking aggressive action within the 26-County area remains unaltered and the Resistance takes its stand against any attempt to foment sectarian strife which is alien to the spirit of Irish Republicanism.

The Irish Resistance Movement renews its pledge of eternal hostility to the British Forces of Occupation in Ireland. It calls on the Irish people for increased support and looks forward with confidence – in cooperation with the other branches of the Republican Movement - to a period of consolidation, expansion and preparation for the final and victorious phase of the struggle for the full freedom of Ireland.

EFEAT should not be taken lightly and certainly not welcomed. It should be a wakeup call, but not when the defeated surrendered and see it as a plus.

Defeat does not mean you are beaten, if you are committed to what you aspire. That is the difference between true Irish Republicans and the sham Republicans who let ego be a substitute for commitment.

The truth must be told that the socalled Irish Lobby has been defeated and has surrendered to the enemy and it is a one-way surrender that was not demanded but offered and in return the defeated get nothing to show for their

The Irish Lobby (IL) spear-headed by the Irish National Caucus, Ancient Order of Hibernians and others, saw the chance to get a foot in the door to and acceptance in establishment and they took it and the price was their political souls and any honour they may once have had.

They broke their word to the Republican Movement (RM) in a gradual process, and became green unionists. Irish American leaders let their growing personal egos get in the way of true commitment. They wasted a once-great effort and bowed to the master of greed.

Let is not forget that the Irish-American Community when they decided they wanted to help in the campaign to oust the British from Ireland sought out the Republican Movement's endorsement of their efforts. That endorsement gave them

The Dublin government was not going to endorse a campaign to rid Ireland of the British. Britain's presence was the assurance that the Free State would remain. Dublin might give lip-service, but it was never for real. They supported Northern Unionism which also guaranteed the Free State status quo.

REPUBLICAN IRELAND

A Republican Ireland of 32 Counties was never meant to mean the 26 swallows up the Six, it was for a New Ireland (ÉIRE NUA). Unionism and Britain were the Free State's guarantee of its existence. People lose sight of

When the American Irish wanted to be part of the effort to drive Britain from Ireland, they accepted that that involvement meant the Republican Movement called the shots on the direction of the campaign. The Americans accepted that premise and welcomed it.

The RM set the stage and the Americans acted it out. It had always been like that. What goes on in the United States is to supplement what goes on in Ireland. The Irish Lobby was supposed to be the voice of Republicanism in the States. We were all supposed to be on the same page.

Without the quest for Irish unity and Independence precipitated by a declaration of intent withdraw, there is no reason for the Irish Lobby. The acceptance of the "peace" process is a total utter unconditional surrender and there is no way to sugar-coat it. What happened?

Surrender is one of two things: (1) it is to realise the other side is so strong vou do not want to waste resources, so you live to fight another day for the same goal and you never accept defeat and the second is simple, pure unadulterated cowardice. The IL are cowards.

The cause of Irish freedom is now brushed aside in favour of a seat at the big table of US domestic politics. To get in, you accept the "peace" process and it's sealing of defeat. The collective cause of replaced by the individual ego. The IL leaders would rather preach

eace at any price than stick to the mission they once embraced. Recent discovered documents show that in 1973, 104 Congressmen endorsed the Tip O'Neill, Joe Moakley and Floyd Spence sponsored-letter asking colleagues to sign onto a peace plan that sets the blueprint for a New Ireland.

When Tip O'Neill later joined with Senator Ted Kennedy, Senator Daniel



Movnihan and others in a Free State endorsed campaign against the IRA, he never retracted the endorsement of the ÉIRE NUA plan. People forget that.

The "peace" process was not a plan but a surrender. **ÉIRE NUA** was a system of government that showed the future for all the Irish people. The peace at any price could have been had way back in 1972 by the nationalists accepting unionism. They have know done that through the "peace" process.

HE Irish Lobby is now

irrelevant. Once it turned its back on Irish Republicanism, it lost credibility, because it accepted Partition and British rule. And no one wants to hear the foolish term "stepping-stone" The only stepping-stone is for the British to announce they are leaving.

The Irish Lobby likes to point to its so-called political victories which are a cover for eventual failure. The victories are all meaningless.

The first was when they accepted human rights as the driving-force rather than the primacy of unity and freedom. They did this under President Carter. The British were convicted of human rights violations but the United States did not come down on them and impose

Then there was the gun ban to the That was a token for fools. Ronald Reagan signed off on the ban but ignored it and gave the RUC all the weapons needed. Remember he also condemned the hunger strikers, praising Thatcher's treatment of them.

The MacBride Principles got a lot of publicity and were a major diversion from unity and freedom and it turns out that behind the scenes the British welcomed the diversion.

The IL thought they were really on top of their game when they got a commitment from presidential candidate Bill Clinton to get involved in the Six Counties, Clinton got to play the stage Paddy and the fools lined up behind him

What did Clinton do for the Irish? He turned them into unionists because he was. Clinton appointed George Mitchell to work out a plan and it turned out to be an acceptance of "peace" and the Union. He had worked this out with the British and Free State

LAPSED REPUBLICANS

He gave a visa to Gerry Adams and other lapsed Republicans to come to the States and tell the IL it was alright and they would assume power in a temporary Stormont. It was all a lie. They were through and just wanted money and political power and it did not matter what government they served.

The Irish Americans were rewarded with access to the White House for a drink with the president and a big Paddy's Day party and to look like they did something. They were in fact neutered. It was all about "peace

This year shows what it is really all about. President Obama has postponed the Paddy's Day party so he can give a big state dinner for the British. What an

The White House is supporting the British government's effort to get the IRA papers from Boston College when participants were promised confidentially.

The British want to open up to prosecutions of IRA people when there was supposed to have been an amnesty. It is all lies, but the insult to the IL is well deserved for their act of cowardice in accepting peace at any price and breaking their word to true Republicans to accept nothing less than a British withdrawal.

Now the IL has no leverage and neither do their cousins the Provos. They gave that up when they surrendered unilaterally. They operate from a position of weakness

The True Republican Movement gave birth to the Irish Lobby and was its sponsor and they were the harbinger of legitimacy, where the Six and 26-County governments are the harbingers

PEOPLE lose sight of the simple fact that the Print 1 fact that the British created the 26 at the same time they created the Six and they have been in operation for 90 years. Time does not obscure legitimacy, it only highlight traitors.

Irish unity and freedom is a sacred trust and Partition is a diabolical fraud.

To quote a legal phrase, anything that comes from Partition is "fruit of the poisonous tree". The Free State and Stormont are the twin towers of Partition and the Provos, and the Irish Lobby are its poison.

Everything the IL condemned from the outset of its Irish Republican campaign has now been adopted. It was like a mass defection to the enemy.

The greatest American general and military tactics expert during the American Revolution let his ego get the best of him, so he switched sides and joined the British. We have many examples of General Benedict Arnold today who let their egos take over and they too joined the British.

Immediately the International Monetary Fund arrived and told us that we were broke and needed a bailout. When Brian Lenihan (unfortunately no relation of Brian Boru) pointed out that he had been crafty enough to borrow enough money to keep the ship afloat they got angry and

made him an offer he couldn't refuse. Badly shaken and much stirred he signed away our independence on the dotted line.

Then Olli (Big Bird) Rehn said we needed to pay exorbitant interest rates on the money which couldn't be reduced.

Ask them how much the Irish lads who died on the Somme are worth. Ask them what compensation they will pay for the 60,000 Irishmen who fought them between 1939 and 1945. Ask them what they want to pay for bombing Belfast and Dublin.

In other words ask for War Reparations (remember they just finished paying the French and Brits those First World War reparations last year?).

Now I think that would leave them still owing us some money after all their bond-holders are burned. Not to mention an apology for mistaking us for Jews. Sorry, shouldn't have said that. It was the Nazis killed

the Jews. The Germans were on holiday at the time (or so some would have us believe).

Maybe I should just leave all this to the financial experts like Gerry and Enda and Éamon and everyone else who would rather forget the past than face up to reality.

The reality, of course, is that the big powers in Europe are on the move again and we are in the way.

Open letter to Provisionals from O'Hara, Devine families

THE following letter from the O'Hara and Devine families appeared in the *Derry Journal* on February 10.

Morrison Jim Gibney,
Martin McGuinness, Tom
Hartley, and Bik McFarlane.

We welcome the fact that Danny Morrison has broken his silence and has given some nsight into the events of the first week of July 1981 concerning he hunger strike in Long Kesh. In that light we would like to ask a few questions in the hope of getting answers that may finally but to rest the events surrounding the tragic deaths of our loved ones.

Danny has stated that he elayed the contents of an offer to the PIRA prison OC, Bik McFarlane, on July 5 1981.

Richard O'Rawe, the prison PRO, has said that Bik sent him lown a comm detailing what was on offer, and that he said to Bik "Tá go leor ann." (There is nough there). This has been verified to some of our families by two ex-Blanketmen who had

been there on the wing and heard the words.

Also, Bik himself, in a press interview in 2009, finally admitted he had had a conversation with Richard, and that he thought the Brit offer was "amazing." In light of this, we must assume that Bik made his and Richard's views known to their outside leadership.

What we would like to know

Q1. Why was this not accepted?

Q2. Who, on the outside overrode Bik's authority?

Q3. Why was the Hunger Strike allowed to continue, on direction from the outside (not the POWs)?

Q4. Mrs McDonnell asked Gerry Adams to save her son's life to end to the Hunger Strike by ordering the POWs off it. Mr Adams' reply was that he did not have the authority to do this. Who had the authority (Brendan McLaughlin was ordered off it

Q6. Why was the IRSP (who were joint participants in the Hunger Strike) not informed about the offer through Mountain Climber?

Q7. The British sent you their offer (to be released upon the ending of the Hunger Strike) in the form of dictated statements on the 6th and 20th of July. Why were these statements never shown to the POWs?

Q8. Who took the decision

to withhold the statements from the hunger strikers and the prison leadership?

Q9. On the 29th of July, Gerry Adams told the mother and father of Kieran Doherty, and the hunger strikers, that "there was no deal on the table, no movement of any sort" despite him being at the centre of on-going communications /

negotiations with the Brits from July 4 to July 20.

Why did Adams deliberately mislead the hunger strikers? Did he think that they might call off their fast if they found out what was really happening? We should not forget that four of those men who listened and joked with Adams, went on to die horrible deaths in total

ignorance of what the Britisl were offering.

In Danny Morrison's recent letter he spoke of the 'families' pain'. Danny can't even hope to imagine the pain felt by some of our families. We, the undersigned, believe that the

Hunger Strike was prolonged when an honourable settlement was available, a settlement that would have

saved the lives of six brave men.

We called for an independent inquiry three years ago, asking all those involved in this matter to attend. Only Richard O'Rawe and the late Dr Garrett FitzGerald said they would attend.

We once again call for on Gerry Adams, Danny Morrison, Jim Gibney, Martin McGuinness, Tom Hartley, and Bik McFarlane to attend. The least we deserve is a reason why they won't attend, and failing that, they could provide answers to
