SPECIAL COURTS

PEOPLE'S COURTS

part one

There are a number of reasons why some form of People's Courts should be established in Republican areas and these, is some suggestions for constructing such a system will be discussed below. It is necessary, firstly, to emphasise that the exact composition, scope of authority, procedures used, laws implemented, and numerous other points must be worked out on the basis of the experience of the people themselves. This is the only way in which a system can be developed which recognises and fulfills the needs of the people.

As was pointed out in the last letter, enough groundwork has been done for the first steps towards implementation to be taken; all that remains is for a representative conference to be called together in order to work out a final detailed plan for the initial sceme.

It has been said however, that now is not the right time to impliment a programe of People's Courts or People's justice. Such a view will not stand up to close and objective scrutiny; the same thing was said at the introduction of Dail Uladh: now it is more than a year later and if the courts had been set up then we would have had a positive record of achievement by this time. It was also argued that the time was'nt right during the liberation of Derry in 1970, but what happened? What positive constructive structures were created? What remains? Free Derry could have been the glorious example of fairness and humanity, Republican justice, Incorruptable; IT IS TRAGIC THAT THE OPPORTUNITY WAS LOST.

One can point to other cases; in our own history Sinn Fein courts continued to operate while 100'000 British troops occupied the country these courts where acknowledged by the British colonial administration to be a thorn in their sides, but they were seen by all to be impartial that they were used by the British interests at times to judge issues. Further afield, in the Warsaw ghetto, an alternative state was created and maintained courts and all under the noses of the Nazis. The aims of a system of People's Courts and the reasons they should be established need to be made clear so that dialogue, which must develop on the subject will be objective and clear-minded, and be cause the nature of these aims will

to a large extent influence the structure of the system we create.

It would seem that there are four main aims, and although intermelated, they are capable of seperate analysis.

- 1. Service
- 2. Political
- 3. Educational
- 4. Humanatarian
- 1. SERVICE; There is no doubt that a variety of forms of wrongful behaviour occur in all areas of the country, Republican areas are no exeption. People in these areas want some form of "law and order" and they deserve something better than they have had.

If Republicans do not provide this service a dangerous vacuum will exist, and some "force" or other will attempt to fill it, possibley with the aquiescience of a lot of tired and desperate

people. We must provide an alternative, and it can no longer be simply "rough justice! It should be pointed out that all over the world where people have struggled for fredom they have set up such systems as we are discussing, as a service for and by the people and it is an exception to the rule not to do so.

2. POLITICAL. The benefits to the community will strengthen the people's resolve to have their own system on a permanent basis and will make its extention on a nationwide basis more probable. Further, the people will have firm evidence ; that the movement possesses the administrative capacity to lead them into a new Ireland in addition to the military capacity to get rid of the old. The political benefits cannot be stressed enough; as we all know the present campaign, on both sides, is right now and will continue to be both a military and political struggle.

5. EDUCATIONAL. People in the area where a People's Legal System is being crested will truly be shaping a

new society the maximum num-ber of people are citizens in the fullest sense. (Emmet O'Connell on Dail Uladh) They will have created somsthing that they understand and appreciate; and will fight to maintain it. They will realise fully that the difference between their system and any "reformed" system based on the English modelis a difference in kind and not in degree. Furthermore, the peorle will learn through experience, how to deal with the many social evils which are rampant in the world to-day....from the social welfare "paradise" of Sweden, to the bosom of Capitalism-Nixon's corrupted

giant... and which everywhere are simply inflamed by the use of police repression. It should be remembered that wrongful behaviour, libe Civil Rights activities, cannot be eliminated by force. It is useful to consider here the contrast between the envisaged People's Courts and the regime's "Special Courts."

4. HUMANITARIAN. It has been made clear in previous issues that a more humane approach is needed in our procedures for dealing with persons who have behaved wrongfully. It should also be stressed, most emphatically, that our system would include provision for humane treatment for victims, according to their suffering. This is an area where there has been little, if any, provision made in present or past systems. We would, of course, continue to follow as much as possible the policy of no stigma, and no humiliation, which was often, though not always, a part of Republican justice. By following these policies, based on guidance and assistance, reconciliation and compensation, we would create a more positive attitude in our own wrongdoers, our victims and inevitably in ourselves because of our pride in a job well done. Only this week British soldiers broke outside lights on the porches of homes in the Andersonstown estate.

The security chiefs have made up their minds that NO Catholic areas will have street lighting. O'Shea obviously believes his friends in Stormont when he cries his crocodile tears.

The people of the occupied areas should be under no illusions, the street lighting will NOT be turned on inside the estates. People like O'Shea are leading the people up the garden path, they are working in collusion with the Whitelaw administration in suppressing the natives. O'Shea is one of the Alliance candidates in the forthcoming???? elections. We will have a chance to see just how many people give their support to a man who does all his talking from the safety of his own home while the electorate suffer.





Let us raise our hats and drink to brave Sergeant Prendan Keys who arrested Maire Drumm during the week. Keys follows in the tradition of the Griffiths, the De Valeras, the Costellos and the Lynchs who have sold their souls to John Bull. 
12 YEARS?
