Within one week of being removed from his job in repressing the Nationalist community in Ireland, Douglas Hurd, the new Home Secretary, was given a sharp reminder that the lessons of Ireland are being well learned over here. The Black and Asian youth of Handsworth in Birmingham, following in the footsteps of their Irish brothers and sisters, took up the revolutionary weapons of the brick and petrol bomb and attacked the police - the front line force of British state oppression.

Readers of IRELAND'S WAR should be clear of two things. One, this was not a 'race riot' as the gutter press would have us believe. This was not the Afro-Caribbean community. Nor was it the Asian community. Nor was it the Black and Asian communities against the white community. No, the actions of the Black and Asian youth were a direct response to the repeated and neverending harassment they are subjected to at the hands of the police; a response to the institutionalised state racism of immigration controls and discrimination in housing, health care, education and employment; a response to the growing numbers of racist attacks on Black and Asian people being carried out by the fascist thugs of groups like the NF

and the British National Party. And, indeed, far from this being any sort of 'race riot', the revolutionary assault on the police in Handsworth united Black, Asian and white youth, many of whom are Irish, in opposition to the poverty and deprivation which affects the whole of Handsworth's poor, working class community.

Secondly, the Black and Asian youth have demonstrated yet again that they will take revolutionary action to defend themselves and their communities and to destroy the forces of racism, imperialism and exploitation. Armed with the slogan "HERE TO STAY! HERE TO FIGHT!" the Black and Asian youth have stepped onto the revolutionary path, the path to freedom. And, as Handsworth demonstrated, the Black and Asian youth, as a vanguard revolutionary force, were able to win support from white working class youth in opposition to oppression.

It is for these two reasons that all IRELAND'S WAR readers, all progressive people must give resolute support to the Black and Asian youth and their emerging revolutionary organisations. The struggle of the Black and Asian community, like the Republican struggle in Ireland, is the struggle of all oppressed and exploited people.

If we are to be believed when we say we stand for an end to British imperialism and the establishment of freedom and justice then we must say that wherever and whenever British imperialism is attacked we are with those forces of freedom. The Black and Asian youth are our allies in the struggle against British imperialism. On not be fooled by racist propaganda. Do not fall into the British state's 'divide and rule' tactic. Stand with your Black and Asian brothers and sisters and extend to them the hand of revolution ary solidarity. Furthermore, man the front lines of revolution alongside the Black and Asian youth. Together we can smash British imperialism once and for all.

# Vol. Ray McLaughlin

It Is with great sadness that we report the death of IRA Volunteer Raymond McLaughlin. At the early age of 33 he died on holiday while swimming with his wife and 11 year old son

Raymond McLaughlin lived in England for some years and while there he took up the cause of Irish freedom. He was captured in Coventry after a premature explosion in which his comrade James McDade died. Raymond was imprisoned for nine-and-a-half warm. nine-and-a-half years, being released in December 1983.

Inside and out of prison Volunteer Raymond McLaughlin remained an Irish patriot and Freedom Fighter. While in English prisons he took part in many protest actions in defence of Prisoners' rights, on behalf of both Irish and non-Irish Prisoners.

Despite being refused the right to repatriation while a Prisoner, on his release the British state, operating its double standards, served an Exclusion Order on him and sent him back to Ireland where he immediately became sent him back to Ireland active as an IRA Volunteer.

Raymond McLaughlin was buried with full Republican military honours. On Thursday 12 September an IRA firing party paid their final tribute to him and on Friday 13 September he was buried in Buncrana, Co. Donegal. The funeral cortege was led by an IRA Guard of Honour and hundreds of Republican people turned out to pay their last respects. However, even in death Raymond McLaughlin was to suffer state harassment. Hundreds of Gardai in riot was to suffer state harassment.Hundreds of Gardai in riot gear tried to disrupt his funeral and his family and the mourners were subjected to scenes of intimidation mourners were subjected to scenes of intimidation normally associated with RUC provokation at Republican funerals in the occupied 6 Counties. It is to the credit of his family, friends and comrades that, despite this, Volunteer Raymond McLaughlin was buried with dignity and Volunteer Raymond McLaughlin was buried with dignity and pride. Sinn Fein President Gerry Adams MP, paid tribute to Raymond McLaughlin at his graveside telling mourners that the best way to honour his memory was for people to go back to their own areas. go back to their own areas and organise.

The Republican Movement and freedom loving people across the world have suffered a great loss in the tragic death of IRA Volunteer Raymond McLaughlin. However at this time we especially send our sympathy and condolences to his wife Mary, his son Patrick and his family circle.. MD.

- IN TRELAND.
  RELEASE OF PRISONERS FRAMED BY THE
  BRITISH POLICE.
- 3. AN END TO SOLITARY CONFINEMENT AND SPECIAL CONTROL UNITS.

  4. RELEASE OF PATRICK HACKETT ON MEDICAL GROUNDS.
- ABOLITION OF THE PREVENTION OF TERRORISM ACT.

The Committee will also highlight the plight of Prisoners' relatives in travelling to and visiting their loved ones, held as political hostages by the British state.

## Soviet Youth support | WORDS AT WORK Irish freedom

July 27 to August 3 saw the 12th World Pestival of Youth and Students take place in Moscow around the theme "FOR ANTI-IMPERIALIST SOLIDARITY, PEACE AND FRIENDSHIP". Hundreds of thousands of people from over 153 countries attended this major event, including a 120 strong delegation from Ireland. July 27 to and Students

Among the Irish delegation were victims of British repression including, ex-Armagh prisoner Briege Brownlee repression including, ex-Armagh prisoner Briege Brownlee of the anti-strip-searches campaign, Brenda Downes(widow of plastic-bullet victim John Downes) of the United Campaign Against Plastic Bullets, and Desi Breslin of the Stop the Show-Trial Committee. These 3 representatives received messages of solidarity from delegations from Nicaragua, El Salvador, Chile, Grenada, India and Cuba. The leader of the Soviet Youth delegation, speaking at a tribusel on anti-colonialism.condemned British repression tribunal on anti-colonialism, condemned British repression in the six counties.

#### CENSORSHIP BACKFIRES.

A group from the Irish delegation had intended to display the BELFAST EXPOSED photographic exhibition, (which portrays the reality of life in the occupied City), in the Exhibition Hall where each delegation had a stall. However in an attempt to censor the truth on Ireland the "Workers Party", Fianna Fail and Fine Gael members in the Vouth delegation demanded that the BELFAST EXPOSED Youth delegation demanded that the BELFAST EXPOSED exhibition be removed. This attempted censorship backfired when the Soviet Youth organisation, in an outstanding act of proletarian internationalism, agreed to show the BELFAST EXPOSED exhibition in their own headquarters. As a result many more people saw it there than would have see it in the Exhibition Hall.

Despite the attempted censorship by the other Irish groups, and thanks to the solidarity of the Soviet Youth delegation and other anti-imperialist delegations, the six-county delegates and the Republicans who attended the festival were satisfied that they had not the festival across in the true spirit of "ANTI-IMPERIALIST SOLIDARITY, PEACE AND FRIENDSHIP".

## BARLINNIE

Desmond Tighe of Wishaw, Scotland, spends his summers at the same 'hotel' every year. From 1979 to this year, courtesy of the Wishaw police and HM's government. Desmond has been sent to HMP Barlinnie, Glasgow to spend 3 months - June, July and August - on remand. Each time, apart from one occasion, the charges brought against him have been thrown out of court. And on the one occasion he was found guilty the charges were dismissed on appeal.

latest incident Desmond reports that on June 21 this year the police, without a warrant, smashed in his door at 2.45am. His 2 young children were absolutely terrified by the police's banging, kicking and shouting and his 18 month old daughter almost sustained injury at the hands of these plain clothes thugs. Desmond's initial thought was that his house was under attack and he took steps to defend himself and his family. This resulted in him being charged with 'police assault'. Once again the police, minus a warrant and in plain clothes, smash into someone's house and then charge their victim with 'police

Desmond asked GIFAC members to visit him in Barlinnie and to publicise his case. We fully support him and demand that the police end this campaign of harassment against him. The police should note - this type of behaviour on their part in Toxteth and Handsworth has led them to run for their lives!.

# Mr. James (77) charged with PTA

## STRIP SEARCHES

In IW 14 we reported on the arrests and charging under the PTA, of 14 people following raids throughout Scotland and England.

ll of those arrested are being held on remand in HMP Brixton, London and they report that they are suffering constant harassment at the hands of the screws.

The cases of the two Irish women being held, Martina Anderson and Ella O'Dwyer and Irishman Gearóid mac Domhnaill, illustrate what they are being subjected to.

On 11 September Ella O'Dwyer reported that she and her comrade Martina were being strip-searched on an average of 7 times a week. By the end of September they had undergone a total of 86 strip-searches and 216 body searches. The women also report that they receive very little association and cell checks are carried out "very often". In August Ella was put on 'punishment' for 7 days for speaking to a fellow Prisoner through her cell window. And the following week she and Martina lost 1 week's association for speaking to a Prisoner in another block.

On 29 August Gearóid mac Domhnaill was forcibly moved to a cell whose window was covered by perspex sheets with half-inch drill holes for air. Behind that was an old steel window frame then 2½ inch broad bars running across, other bars down. Behind that wire grill allowing very little visibility then another grill, more bars and three feet away, a double sheet of mesh wire fencing! Gearóid reports that the lack of natural light forces him to have his cell light on even if the sun is shining giving him constant headaches. He is almost totally isolated and reports that the male remand Prisoners arrested with him are also being strip-searched.

This treatment is not carried out for 'security' reasons. Where's the 'security' problem in allowing a Prisoner fresh air and sunlight? Where's the 'security' justification for strip-searching Prisoners who are almost totally isolated from all but screws?To quote Gearóid mac Domhnaill

"It's all harassment, just like the strip-searches on the women (and us too) - they're not security - I could see it maybe being that once in a blue moon, but not this regular routine which amounts to torture/inhuman and degrading treatment and a sadistic treatment of any human being, male or female. It's visual rape and the women POWs deserve great praise for their courage and dignity in the face of such attacks on them."

We must make our voices heard in support of these Prisoners. Write to Douglas Hurd, the Home Secretary, at the Home Office, Queen Anne's Gate, London to protest on their behalf. Do not let them stand alone.

On Saturday 24 August a 77 year old man, Mr. James, was arrested under the Prevention of Terrorism Act in connection with IRBLAND'S WAR during a Republican march in Carfin, Scotland

The march, organised by the Wolfe Tone Flute Band, Craigneuk and the Spirit of Freedom Flute Band, Cleland, was around 1,000 strong with a large uniformed police presence before and during it.

Despite his age and frailness Mr.

James was held over the weekend by
Bellshill police and appeared in

Eamilton Sheriff Court on Monday 26

August charged under Section 2 of the
PTA that:

"He carried and displayed a document entitled 'Ireland's War' in such a way and circumstances as to arouse reasonable apprehension that he was a member or supporter of a proscribed organisation, namely the IRA, contrary to Section 2 of the PTA."

During his detention over the weekend the police told his family, his lawyer and Joan Maynard MP that they had dropped the PTA charge against him - THIS WAS A LIE!

LABOUR MP CONDEMNS STRATHCLYDE POLICE

Joan Maynard MP condemned the arrest and phoned Strathclyde police on the Saturday night to demand Mr. James' immediate release. She expressed her extreme concern at recent attacks on the domocratic rights to free speech and in particular the right to speak out on Ireland. She drew the link between the arrest made under the PTA and the banning of the BEC's 'Real Lives' programme - both were attacks on the democratic rights to free speech and the freedom of the press, she said

## PTA ISOLATION BROKEN.

Throughout the weekend Bellshill police station was inundated with phone calls from friends, family and supporters of Mr. James. GIFAC contacted the press and individuals and organisations throughout Scotland and England, all of whom expressed concern at Mr. James' arrest. A lawyer was contacted on his behalf and full marks go to the Wolfe Tone Flute Band who constantly phoned the police all weekend, ensuring that the usual isolation that surrounds PTA victims was broken and that Mr. James was not standing alone. Indeed, so aware were the police of the strength of support for Mr. James that when he asked if he would have a lawyer for his Monday morning court appearance, they commented that not only had a lawyer already been in touch with them but so had hundreds of other people! They didn't foresee any problems in his having a lawyer in court!





## RESISTING POLICE INTIMIDATION.

Despite his weekend in police custody Mr. James emerged in a fighting spirit. He gave his full backing to a public campaign in his own defence and in defence of IRELANDI'S Mar. On Saturday 31 available opportunity it was important to be on the streets selling IRELANDI'S WAR. On Saturday 31 August GIFAC members supported by the Revolutionary Communist Group (RCG) and an observer from the Scottish Council for Civil Liberties turned out at the Celtic v Rangers football game at Celtic Park to show that we had not been intimidated by the police. Apart from minor police harassment GIFAC and the RCG sold their newspapers and re-stated the right to free speech on Ireland and the right to sell anti-imperialist literature.

## Mr. JAMES

LIFE LONG REVOLUTIONARY.

Mr. James joined the Communist Party of Great Britain in 1932 and remains a member to this day. During his lifetime he has remained a consistent activist, communist and supporter of all progressive struggles across the world.

During the 1930s Mr. James was a local organiser for the National Unemployed Workers Union and a member of the Union's JOHN MacLEAN FLUTE BAND.

He fought with the 15th.
INTERNATIONAL BRIGADE in the Spanish
Civil War, was captured at the battle
of Jarima and held as a Prisoner of
War by the fascists for several
months.

During World War 2 he served with the British army in India and in his free time worked with the Communist Party of India. He joined the GIFAC two years ago and is a supporter of the Scottish Communist Republican Party. He is currently active in the Glasgow Anti-Cuts Campaign.

THE FOLLOWING DAY THE SUNDAY POST CARRIED AN ATTACK ON IRELAND'S WAR AND STRATHCLYDE POLICE OPENLY DECLARED IN AN ARTICLE IN THE GLASGOW HERALD. THAT THEY WOULD COME DOWN HARD' ON ORGANISATIONS WHICH SUPPORT THE IRISH CAUSE OF FREEDOM AND NOW THIS MAN HAS BEEN ARRESTED UNDER THE PTA.

#### NEW WAVE OF REPRESSION.

SINCE THE HUNGER STRIKE IN 1981 SUPPORT IN SCOTLAND AND IN ENGLAND FOR THE IRISH REPUBLICAN MOVEMENT HAS GROWN. THE IRISH COMMUNITY IN THE WEST OF SCOTLAND HAS ORGANISED ROUND THE REPUBLICAN BANDS. AND NEWSPAPERS SUCH AS IRELAND'S WAR HAVE GROWN FROM STRENGTH TO STRENGTH.

IN RETALIATION THE STATE HAS LAUNCHED A NEW WAVE OF REPRESSION AGAINST THOSE WHO WOULD SPEAK OUT ON IRELAND. RECENT ATTACKS ON IRELAND'S WAR MUST BE SEEN AGAINST THE BROADER BACKGROUND OF ATTACKS ON THE IRISH COMMUNITY: THE BANNING OF THE BBC'S 'REAL LIVES' PROGRAMME: BBC MANCHESTER RADIO'S 'IRISH LINE' PROGRAMME RUN BY THE IRISH IN BRITAIN REPRESENTATION GROUP (IBRG) HAS BEEN WITHDRAWN BY THE BBC BECAUSE IT WAS TO DISCUSS ISSUES SUCH AS THE PTA AND STRIP-SEARCHING IN ARMAGH: THE BANNING BY THE POLICE OF AN IRISH CONCERT IN BEDFORD ON THE PRETEXT THAT IT WOULD BE USED AS A VENUE FOR COLLECTIONS FOR THE IRA: A RECENT INCREASE.IN THE ARREST AND DETENTION OF IRISH PEOPLE IN SCOTLAND AND ENGLAND UNDER THE PTA AND POLICE OPPOSITION TO THE LEEDS IRISH CENTRE BEING USED BY THE IBRG FOR IRISH LANGUAGE CLASSES. ALL THIS IN AN ATTEMPT TO CRUSH THE GROWING AWARENESS OF IRISH PEOPLE HERE OF THEIR NATIONAL IDENTITY. THEIR GROWING CONFIDENCE IN SPEAKING OUT AND TO STEM THE TIDAL RETALIATION THE STATE HAS LAUNCHED IRISH PEOPLE HERE OF THEIR NATIONAL IDENTITY, THEIR GROWING CONFIDENCE IN SPEAKING OUT AND TO STEM THE TIDAL WAVE OF SUPPORT FOR IRISH FREEDOM.

#### PTA REPRESSION EXTENDED.

THE PTA IS NOW BEING EXTENDED AND UNDER NEW MEASURES OVERSEAS MOVEMENTS SUCH AS THE PALESTINE LIBERATION ORGANISATION (PLO), THE AFRICAN NATIONAL CONGRESS (ANC) AND THE JAMMU AND KASHMIR LIBERATION FRONT (JKLF) TO NAME BUT A FEW, COULD BECOME PROSCRIBED ORGANISATIONS. THUS SUPPORT GROUPS FOR SUCH MOVEMENTS WILL FACE THE SAME HARASSMENT AND PERSECUTION AS HAS BEEN METED OUT TO THE IRISH COMMUNITY AND SUPPORTERS OF THE IRISH REPUBLICAN MOVEMENT. MOVEMENT

#### WIDESPREAD IMPLICATIONS.

The charge under the PTA is an extremely serious development with widespread implications affecting all progressive organisations. Mr. James, at the age of 77, faces a possible prison sentence and/or a large fine. If the police are successful in criminalising Mr. James then all IV sellers will face the possibility of similar will face the possibility of similar are the direct threats facing Mr. James charges. These are and IRELAND'S WAR.

#### IRISH SOLIDARITY UNDER ATTACK.

However, the British state is not simply trying to silence IRELAND'S WAR. It wishes to censor all publications which tell the truth about Ireland. It wishes to stop all manifestations of anti-imperialist solidarity with manifestations of anti-imperialist solidarity with Ireland. If the police are able to get a conviction using the PTA against IRELAND'S WAR then it may provide a legal precedent which could be used against all Irish solidarity newspapers ie. TROOPS OUT.all Irish Republican publications in AN PHOBLACTIPEDIBLICAN NEWS and solidarity newspapers ie. TROOPS OUT:all Irish Republican publications ie. AN PHOBLACHT/REPUBLICAN NEWS, and all anti-imperialist papers ie. SOCIALIST REPUBLIC which give coverage to the struggle for Irish freedom. This attack on IRELAND'S WAR is therefore of grave concern to all those who wish to speak out on Ireland. The campaign to defend Mr. James and IRELAND'S WAR needs the support of all those who defend free speech on Ireland.

#### ANTI-IMPERIALIST SOLIDARITY UNDER ATTACK.

The recent decision to extend the PTA from a purely antilaw into a law aimed at all revolutionary movements throughout the world is also of concern. We have already seen Kashmiri auti-imperialists arrested under the PTA.If the police can establish that giving coverage in newspapers to the Struggle for Irish freedom is illegal under the PTA then, by extension, dozens of publications which support overseas revolutionary movements could face similar charges. The attack on Mr. James and IRELAND'S WAR is therefore of grave concern to all those who wish to speak out on ANY revolutionary anti-imperialist struggle.

#### DEMOCRATIC RIGHTS UNDER ATTACK.

During the Miners Strike we saw a whole range of repressive legislation used against Trade Unionists and their supporters. Once the police have powers then they will be used against every group who rise up against their oppression. The attack on Mr. James and IRELAND'S WAR's democratic right to free speech is therefore at one and the same time an attack on everyone's democratic rights. rights.

## USA corroded



Beneath the gilded exterior of Constitutional rights and Beneath the gilded exterior of Constitutional rights and "Justice for All", the American establishment is corroded. An American citizen is "free" to speak in favour of the Contras (counter-revolutionary terrorists in Nicaragua - Ed.), to recruit soldiers and even supply them with funds and weapons; but the same activities on behalf of the Sandinistas, or the Irish Republican Army bring harassment and prison sentences.

The Reagan administration has demonstrated its ideological opposition to civil liberties by intinidation and entrepment of those who actively support the Irish freedom struggle. Perhaps the most difficult burden is borne by those who are in prison in America for their dedication to Irish freedom. The list included Irishmen who came to America to escape the injustice of the Diplock Courts, Irish and Irish-Americans who were "setup" by the FBI and are now serving sentences for weapons violations, and an American citizen, Liam Quinn, whose active support for Irish freedom led to his arrest in 1982 at the urging of the British government. Liam was charged in the shooting of a London constable, and although an Appeals Court judge ruled in 1983 that his actions clearly fell within the political offence Reagan administration has demonstrated although an Appeals Court judge ruled in 1933 that his actions clearly fell within the political offence exception provision of the extradition treaty between the U.S. and Britian, and ordered him released within 10 days, Liam Quinn is still in prison. Members of the legal profession have expressed outrage over the extent the government is willing to go to keep Quinn in jail. And to ensure that he and others like him never have the chance of gaining freedom, the U.S. Senate is now considering a change in the treaty (already signed by Reagan and Thatcher), which would eliminate the political exception clause altogether. This proposal is retroactive.

A number of bills have been introduced in Congress during Reagan's second term which purport to define and punish "terrorism". Definitions are given in the bills, but the authority to determine what people, groups, and/or nations fall under these definitions is given to the Department of State. Thus anyone whose thinking runs contrary to that of the DOS would be subject to the punishments outlined in this repressive legislation. A defendant would not even have the right in a court of law to challenge the State Department's classification! All classifications would necessarily be politically-motivated.

motivated.

Intimidation by the executive department - the State Department, CIA, FBI, Immigration and Naturalization, and other bureaus, has been unrelenting. We were questioned in our shop by an FBI agent last year about our activities for Ireland. Under the Privacy Act, citizens may request copies of files kept on them by government agencies. Therefore, we requested our file from the state office of the FBI. They denied this request, on the grounds that "it would hamper law enforcement proceedings" and that "the investigation was still pending" - the FBI, however, refuses to say what offences we are suspected of. Following standard procedure, we appealed to the Justice Department in Washington. They also denied access to the file on the same grounds, and released only a copy of a newspaper article about our publication THE IRISE AMERICAN VOICE, which appeared in a local paper. Other activists across the country have been questioned, followed, and had their telephones tapped. There have been numerous incidents of attempted entrapment.

But despite these encroachments on our rights, Americans will continue to speak out for freedom. As one New York supporter stated:

"I feel a sense of outrage that I'm not supposed to get involved in the liberation of my encestral homeland, while such activities by other ethnic groups are allowed, even blessed by the U.S. go vernment. Any attempted publicity by activists is deliberately censored or reconstructed by newspaper editors in order to minimise the cridibility and destroy the impact of the truth. It makes me more defiant."

# NEWHAM 7: self defence is no offence

In April 1984 Asian youth bravely fought white racist thus in Newham, East London, in an operation carried out to defend the East End's Black communities from fascist activity in the area. The local police immediately with the incident.

Outraged by the British state's attempt to criminalise the 'Newham Seven' Black youth and other anti-racists mobilised to support the Newham Seven Defence Campaign. Militant demonstrations and pickets were organised by the two massive demonstrations held in Newham earlier this year, Asian and Afro-Caribbean youth armed themselves with bricks and bottles and fought back. (See IW 13 - Ed.) Seven that when the case finally came to the Cdd Bailey in May this year police, (a number armed with handguns) swamped the area in a fashion that began to resemble the trials of Irish Patriots and frame-up victims in England.



Throughout the trial the Newham Seven Defence Campaign staged pickets outside the Old Bailey. Supporters chanted "Newham Seven innocent - self defence is no offence" and "Whose conspiracy - police conspiracy". As the pickets grew stronger the police carried out brutal attacks and indiscriminate arrests of demonstrators. Such brutality was not restricted to outside the Old Bailey. On the first day of the trial Old Bailey screws attacked and beat up Newham Seven defendant. Parvaiz Khan.

The trial of the Newham Seven exposed a series of police 'irregularities' and cover ups, further exposing the collaboration between the state and out of uniform fascist thugs.

As the trial drew to a close in July the Newham Seven Defence Campaign stepped up its demonstrations of solidarity with the defendants. The Defence Campaign claimed a "morel victory" when the largely white jury delivered its verdict after a deliberation lasting more than 13 hours. Rathar Chaudri, Amjad Ali and Jothi Rajappan were acquitted of affray, causing criminal damage and possessing offensive weapons. The four other Asian youths were, however, found guilty of affray and were later sentenced to 100 hours community service each.

The three white defendants - Roy and Robert Lellow and Stuart Young - were found guilty of common assault and fined £100 each.

Bahadur Khan noted that the state had failed to imprison the Newham Seven and commented with reference to the confrontation in Newham:

"If a situation like that happened again we would once again be forced to fight back. With all these petrol bombings going on the tension is rising and rising, and we can now see what kind of racist attacks are going on in East London. I wouldn't be surprised if something boils up to a really large scale and a riot occurs."

Parvaiz Khan added:

"We knew that the verdict: would be something like this and I think he (Judge Denison) knew that if he had given a heavy sentence there would have been alot of trouble".

Unmesh Desai of the Newham Seven Defence Campaign pointed out that the victory of the Newham Seven:

"demonstrated the strength and success of a defence campaign; not just the strength in terms of individuals, but also in terms of turning the case into an issue, which is the right of 3lack people to defend themselves from attacks using any means necessary."

As the trial of the Newham Seven concluded racist arsonists murdered Shamira Kassam and her three children at their home in Ilford in Essex. Mrs. Kassam and her three young sons, Zamir, aged six, Rahim, five, and Alim, I died after their home was set alight by arsonists in July. Ilford police refused to admit that the massacre was the work of racists and thereafter a campaign of arson attacks was carried out against Asian families living in London and other English cities.

Racist attacks on the homes of Asian families were reported from Leyton and Newham in East London, Bromley in Kent, Birmingham and Brixton. One victim of a racist arson attack in East London, Mr. Kayani, was brutally interrogated by police a few hours after escaping the blaze at his Leyton home.

"I felt as if I had committed a crime. In eight hours they (the police) didn't even offer me a drink of water."

As IRELAND'S WAR went to press racist arsonists had carried out a further attack on an Asian property in Brick Lane, East London.

## SMASH THE P.T.A!

In IRELAND'S WAR No.6 we drew attention to the struggle of the Kashmiri people for independence from Pakistan and India. Over the past year Kashmiri people over here have regularly suffered from police harassment, raids and so on.

In early September the Kashmiri community came under attack yet again. In a series of dawn raids six members of the Jammu and Kashmir Liberation Front (JKLF) were arrested under the PTA. The arrests took place in Birmingham, Lancashire and Luton. Zafar Khan, a spokesperson for the JKLF, stated that the raid in Luton was a military-style operation with a staggering 30 police turning out to arrest 1 man!

Eventually 5 of the 6 were released but Amanulla Khan of Luton was charged with 'causing criminal damage'.

Just as we condemn the use of the PTA against Irish Republicans and Irish Solidarity activists, so we must condemn its use in this case also. The PTA is a police weapon of terror and must be smashed..

Namely Thorazine which in a short time deadens the otherwise healthy men and women so that they can no longer think for can no longer think for themselves. Shock treatment in some parts of the country is still sued to make those who fight oppression more manageable.

We too are physically beaten and mentally down-graded for standing up for our basic rights as human beings. Rights that I will continue to fight for.

We too are strip-searched on a daily basis. It is a barbarian tactic used to humiliate and demoralise not only the prisoner, but the visitors of prisoners as well.

So I can sympathise and understand completely what my fellow Irishmen and women are having to women are having to experience and live with in the English prisons.

## Long Kesh

On Monday 5 August myself and a member of the Wolfe Tone Flute Band (Craigneuk) went to Long Kesh prison on a pre-

Long Kesh, situated just outside Lisburn amidst tight security, is a place well known to those involved directly or indirectly with Ireland's fight.

Myself, being Irish, have been harassed on previous visits. However, because of the presence of a Scottish person we were given the 'softly softly' treatment by the prison officers as part of the Sritish propaganda; we, however, were not fooled by the facade.

We were shown to a waiting room after a humiliating search of our persons, and the taking of our possessions. Just to prove the mentality of the screws, the silver foil was taken from our cigarette packets and we were only allowed a striker and 3 matches.

We were locked in the waiting room for half an hour, then called and shown to a mini-bus which was to transport us to the compounds; again we were locked in.

After being shown through numerous security points we reached the final waiting room only to be told that our arranged half hour visit was cut by 10 minutes. No explanations were forthcoming.

However the spirits of the person we were visiting were high even although the Prisoners are under constant pressure from the screws. The men in this place kept on smiling and made the visit worthwhile.

THE MEMBERS OF GIFAC AND BAZO-PS PAID A VISIT TO THE NEWLY ERECTED GRAVE STONE CF KEVIN'S FELLOW HUNGER STRIKERS FRANCIS HUGHES AND THOMAS MCELWEE.

ON THE SATURCAY THE WOLFE TONE BAND JOINED THE SPIRIT OF FREEDOM BAND TO MARCH THROUGH THEIR HOME TOWN OF PORTADOWN. THE BANDS WERE NOT ALLOWED PORTADUMENT THE TRI-COLOUR ON THE MARCH ALTHOUGH WHEN THEY RETURNED TO OBINS STREET THE TRI-COLOUR WAS HOISTED AND PARADED IN FRONT OF THE RUC.

## **IRELAND'S FREEDOM FIGHTERS**

BELFAST COURTS WRECKED.

Just after midnight on 28 July the IRA proved once again their ability to move lerge quantities of explosives into "high security" areas this time no less than Belfast City Centre. A 1,000 lb. bomb wrecked the Belfast Recorders Court and the Ulster Tavern opposite, seriously damaging the Petty Sessions Court and the Fire Station. Buildings within a 500 yard radius were damaged as these symbols of oppression turned to rubble.

#### COLLABORATOR EXECUTED.

Crown forces have to use Irish-based contractors, builders and supplies for constructing, repairing and nodernising the apparatus of repression. On 15 August the IRA warned that it would not tolerate any of their activities and had extensive information as to who was responsible:

\*....We would remind such collaborators that we view their activities as mercenary making money at the expense of the oppressed nationalist people of the six counties. No amount of argument or self-delusion can obscure that fact. To continue leaves us with no option but to take armed action.

"Furthermore, following the issuing of a similar warning in one locality recently, the businessmen involved approached us with an offer of fl00,000 in return for a 'non-agression' pact. Our attitude is clear on bribes - we are not interested!

"We are of the opinion that the contractors involved are assisting the British in reinforcing their illegal and immoral presence. They are building fortresses and interrogation centres which are being used to oppress our people and subject them to continuing undemocratic rule."


The following week Tyrone Contractor Seamus McAvoy was executed in Dublin having ignored all earlier warnings by phone, letter and attacks on his premises in Coalisland. The IRA statement said:

Rowan cabins and building materials to berracks and military border posts for renovation work was not earning an honest day's pay but was receiving ill-gotten gains. From such military bases, operations have been hatched which have resulted in the murders of nationalist civilians and IRA Volunteers. Within such bases, nationalist people have been beaten and tortured. Without such bases, British military power would be severely hampered. There will be no more warnings."

## IRA DEMOLITION SQUADS WELCOME KING.

If the present rate of bomb and mortar attacks on barracks continues, squads of homeless Brits/RUC/UDR will soon be cast loose in the world, their houses of hate having crashed about their ears, or having been abandoned as unsafe at any price.

On 21 August the IRA planted a 500 lb bomb in a lorry in the cordoned-off area at Plumbridge RUC barracks, Co. Tyrone. Carefully sandbagged on the outer side, the lorry-bomb could only explode in towards the barracks, which it duly did, totally devastating the place.



And on 4 September the largest ever mortar attack using 18 mortar tubes and nearly 1,000 pounds of explosives was carried out on the RUC Training Depot at Enniskillen. The barracks were severely damaged, an observation sangar destroyed, cars in the car park burned out, 19 RUC personnel injured and the new Northern Ireland Secretary Tom King acclimatised to 'normal' life in the North of Ireland.

Over the recent period Brits/RUC have been forced by repeated mortar and other attacks to abandon totally a number of former bases. One of these, the McCrory Park fort in the GAA Athletic Ground had been occupied by Brits since 1972. The Slieve na Bole observation post and also one on the Newry-Crossmaglen road have also been deserted by these rats as they become unsafe at any price. Next stop the bottom of the sea?



#### INLA BICYCLE BOMB.

In a novel approach to the war, the INLA claimed responsibility for a bicycle bomb which exploded on the Dublin-Belfast train on 29 August. The bike was put on the train at Dundalk and a warning given. The train was searched at Newry but nothing found. At Belfast the train was cleared and searched again, during which search the bomb exploded wounding 5 RUC, 2 of them very seriously. On yer bikes Brits!

### NO HIDING PLACE.

On 30 August a 3 person IRA Active Service Unit shot and killed a senior RUC Inspector. The inspector, from Mountpottinger barracks, Short Strand had recently moved from Downpatrick to Crossgar, Co. Down, supposedly a safer area. Nowhere in Ireland is safe for the forces of repression!

#### INFORMERS EXECUTED.

All guerilla wars are troubled with informers. Although few in number in the Irish liberation war, they inflict terrible suffering on the nationalist community, and are objects of loathing to all decent people.

On Sunday 8 September two such informers, Catherine and Gerard Mahon of Twinbrook were executed as touts by the IRA. For 18 months, following Gerard Mahon's arrest for unpaid fines the two had been systematically giving information to the Special Branch for monetary rewards. Catherine Mahon passed on information which led to the capture of 3 INLA Volunteers in Ballymurphy. The Mahons offerit to look after an arms dump for the IRA in order that the Branch could bug it. They actually attempted to assist in the murder of Volunteers. The fate of the Mahons is a firm lesson that the IRA will not tolerate touts, though it has reiterated that no-one who confesses voluntarily will be shot.
