O'NEILL AND THE SHOOT TO KILL POLICY

In the early hours of Monday the 23rd September 1996 Diarmuid O'Neill was executed by the police acting on behalf of the British Government in one of its so called anti-terrorism operations, Diarmuid's brother was arrested at the same time.

O'Neills crime would seem to be that he didn't open the door quick enough in the early hours of the morning and as a result was brutally gunned down, dragged down the steps and denied quick and possibly life saving treatment from medical personnel nearby. People living in the neighbourhood were told by the police not to speak to the press or television crews -WHY- have they something to hide?

Police spokespersons then told of a gun battle where shots were fired and they responded. An elaborate account of how firearms, ammunition and explosives had been recovered was given,

deliberately misleading the public into believing the people inside the house were armed and in possession of a large quantity of explosives. Nothing could be further from the truth!

None of the men arrested were armed or even had a gun, yet alone explosives. These were actually discovered 15 miles away in a rented garage in North London.

The media, deliberately misinformed of the facts continued with the hysterical and biased reporting in England and in Ireland which we have come to expect whenever Irish people are arrested under the Prevention of Terrorism Act. This misleading reporting acts as a judge and jury, finding those implicated guilty without the benefit of a trial.

Since the first reporting of his death and the circumstances surrounding it we now know that Diarmuid was in fact UNARMED and neither guns or ammunition were found in the house where he was killed.

On Sunday the 6th October the monthly picket was dedicated to Diarmuid and was the largest and most emotive one we've had, a call was made for a full public enquiry and a letter demanding the same was handed into Downing St. The picket attracted a large number of people from all sections of the Irish and British communities urgently calling for O'Neills killers to be brought to justice and seeking the immediate end to the use of the PTA.

Fuascailt will continue to campaign for a full public enquiry and will be seeking to raise the issue in the forthcoming weeks, in the media and on the streets.

Duffy's release shows corrupt Diplock system.

In the last issue of this newsletter we carried a letter from Colin Duffy. We are delighted that the RUC frame up against Colin was overturned and 3 years of false imprisonment ended. The case had many worrying aspects especially the prosecution relying on the evidence of (subsequently convicted) U.V.F. gun runner Lindsay Robb.

Outside the court Colin said that the courts were forced to admit they were wrong in sentencing him and his release "only proved what we knew all along that I was an innocent man". When asked by reporters why he was targeted he replied "Because I am a republican." Duffy's solicitor, Rosemary Nelson said that while she was delighted with the appeal court's verdict she was "very disturbed by the nature of the prosecution." Sinn Fein's Barry McElduff said the "verdict was an indictment of the whole Diplock system." Fuascailt sent its best wishes to Colin and Susan Duffy their daughter Caitriona and all those who worked to secure Colins release. Fuascailt received a thank you card from the family for our support.

Repatriation and transfer of

republican prisoners to Ireland.

"Interminable British delays" which have resulted in the repatriation of just two Irish prisoners from England almost a year after the ratification by the Dublin government of the European Convention on the Transfer of Sentenced prisoners were condemned at a Dublin news conference. Sinn Fein POW dept spokesperson Michael "an immediate and Brown demanded implementation of the repatriation facility." Sinn Fein vice president Pat Doherty(whose own brother Hugh has served over 20 years in English jails) told how despite the IRA cessation conditions for prisoners had deteriorated considerably over that period and since. This had been a negative factor in the peace process and combined with British footdraging on the repatriation was a receipe for disaster. Margaret Doherty, mother of Dublin prisoner Derek Doherty one of the three men who were finally cleared to be repatriated told of her frustration at the delay."every time I contact the Department of foreign Affairs the say he is on his way. The papers have been there so long I can't understand what the delay is."

A second press conference Belfast heard that there were 33 republican prisoners held in jails in England. Of these six were now into 22nd year of imprisonment while a further 17 were held in the special secure units in Belmarsh prison. The damaging physical and psychological effects of these units have been widely documented and their continued use condemned by a wide range of human rights bodies and medical experts. Sinn Fein's Michael Browne said the "continued ill-treatment or Irish political prisoners" and the failure of the government to implement the transfer arrangements fell far short of the confidence building measures required and therefore lends nothing of a positive nature to the current situation. Marie Magee whose husband Paul is staging a no-wash and blanket protest against the regime in Belmarsh prison and the delay at being repatriated to Ireland, said she has not seen him for two years. Marie Magee said "Paul will not allow us to visit him because the visits take place in closed conditions. We talk on the telephone for 10 minutes about once a week. " We have some of our family in the Republic so Paul has applied for transfer to both north ans south. It would mean the end of a nightmare for us if he was transferred. Sinn Fein's northern chairman Gerry O hEara said that republican prisoners must not be used by the British government in a peace process bargaining role.

Ella O'Dwyer Urgent appeal for action.

Ella has served 12 years of a discretionary life sentence. Her father whom she hasn't seen for more than 2 years is now seriously ill and unable to travel to see her. Because she is on temporary transfer to Maghaberry the home Office refuses to allow her compassionate parole to visit her seriously-ill father. We ask all readers to write as a matter of urgency to the Home office requesting that Ella be allowed compassionate parole.
