The British policy of forced segregation means that no more than two republican prisoners are kept on one landing where they are surrounded by loyalists, common criminals and drug abusers and in some cases are outnumbered twenty to one. Cells in the prison have been destroyed, fires have been lit and a rooftop protest has taken place to highlight their plight.
